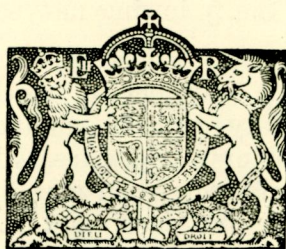

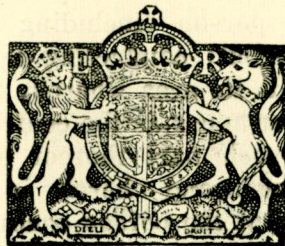

EXPLANATORY NOTE.
