Short title.

Purpose for which Funds may be used. 1. This Act may be cited as the "King George V and King George VI Memorial Act, 1953".

2. The King George V Memorial Fund and the King George VI Memorial Fund may, notwithstanding any trusts affecting the same, be utilised or applied for the purpose of erecting a joint memorial to Their Late Majesties King George V and King George VI. Such memorial shall be—

- (a) in the form of a stone wall and memorial gates and ancillary works associated therewith according to designs approved by the Premier and the Council of the City of Sydney; and
- (b) located in the Sandringham Memorial Gardens situated in Hyde Park in the City of Sydney.




