NAVIGATION (AMENDMENT) BILL, 1954.

EXPLANATORY NOTE.

DOUBT has arisen about the scope of the power conferred by section 113 of the Navigation Act, 1901-1949, to make regulations for preventing collisions at sea.

The object of this Bill is to remove that doubt-

- (a) by enabling regulations to be made under that section in relation to seaplanes for the purpose of preventing accidents at sea-
 - (i) between seaplanes on the surface of the water; and
 - (ii) between vessels and seaplanes on the surface of the water;
- (b) by applying certain sections of the Navigation Act, 1901-1949, which relate to the regulations for the prevention of collisions at sea, to seaplanes on the surface of the water.
