EXPLANATORY NOTE.

THE purpose of this Bill is to ratify an agreement for the variation of the agreement made between the Minister for Public Works and the Councils of the Municipalities of Taree and Wingham on 10th October, 1928, respecting the administration of certain works of water supply for those Municipalities.

- 4A (1) The Board of Management referred to in Clause 6 hereof may with the consent of the Minister instal electrically driven pumping plant and the Council of the Municipality of Taree and the Council of the Municipality of Wingham shall pay to the said Board the capital cost of such works in the proportion of seventy-four one hundredths and twenty-six one hundredths respectively.

 (2) The said Board may from time to time with the consent of the Minister construct additional water supply works for the towns of Taree and Wingham and the said Councils shall pay to the Board the capital cost of such works in the proportion respectively that the population of each Municipality at the date of completion of the additional works as estimated by the Commonwealth Statistician bears to the total population of both Municipalities as so disclosed.
