### EXPLANATORY NOTE.

THE objects of this Bill are—

- (1) to place the establishing and maintenance of cottage homes for defective children established under the Destitute Children's Society (Vesting) Act, 1916, and the care, control and maintenance of such children under the direction and management of the Minister;
- (2) to validate the application of certain trust moneys by the Public Trustee for purposes connected with such cottage homes and the care, control and maintenance of such children.

EXPLANATORY NOTE

The following amendments to the Institute Children's Health (Article) were adopted at the Annual Meeting of the Institute held on the 15th day of December 1954 at the Institute Hotel, London, England.
