Commencing on the southern side of Park-street at the north-western corner of allotment 2 section 12 and bounded thence on the north by that street bearing 269 degrees 39 minutes 2 chains 64 2/10 links on the north-west by a line bearing 223 degrees 55 minutes 27 9/10 links on the west by a public road bearing 178 degrees 12 minutes 4 chains 66 5/10 links on the south-west by a line bearing 114 degrees 8 minutes 35 links on the south-east by north-western sides of Main Road No. 545 bearing 50 degrees 5 minutes 2 chains 15 5/10 links and 33 degrees 7 minutes 1 chain 33 8/10 links and on the east by part of the western boundary of allotment 2 aforesaid bearing 359 degrees 39 minutes 2 chains 51 9/10 links to the point of commencement.
