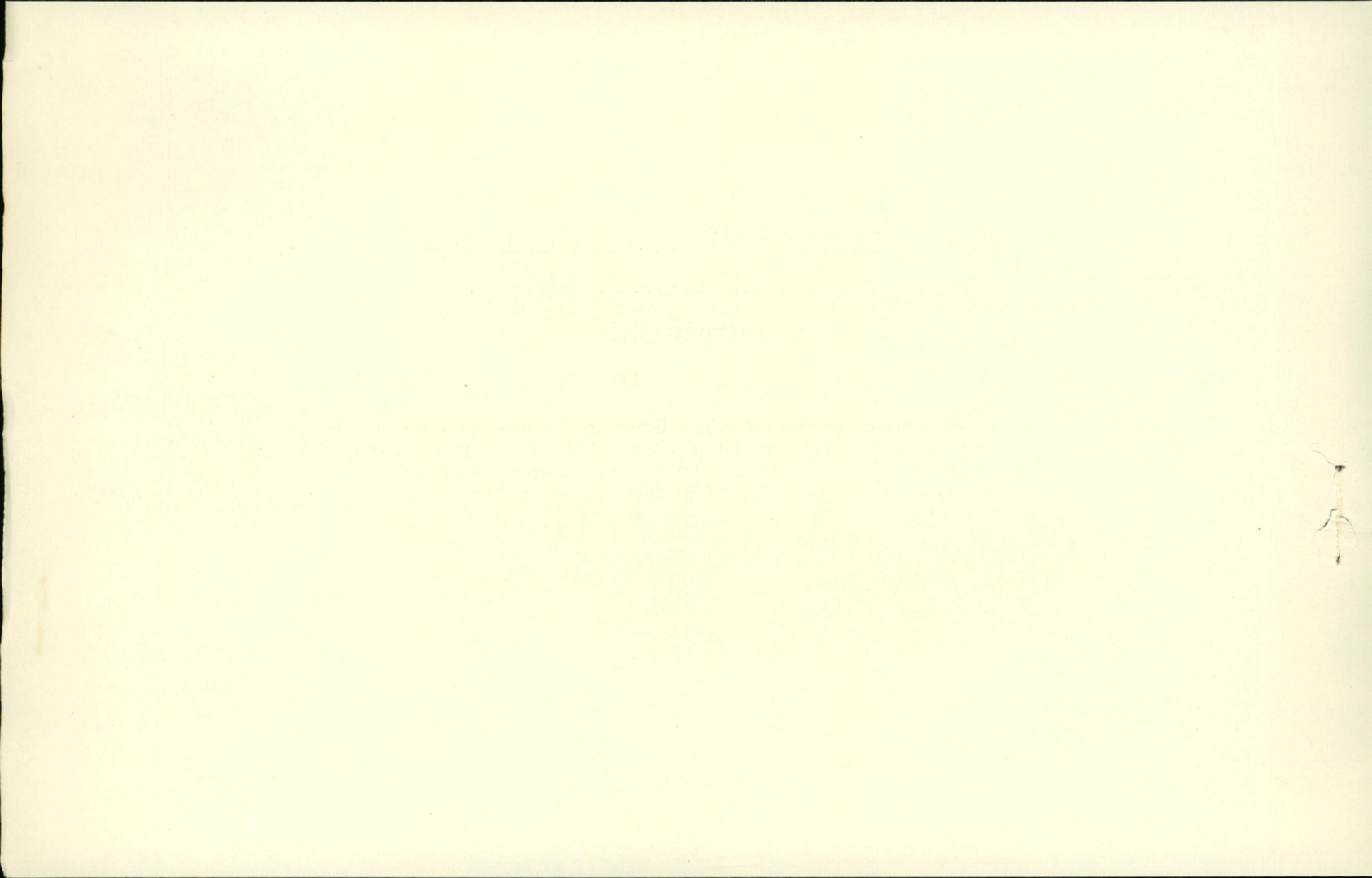

### EXPLANATORY NOTE.

THE object of this Bill is to make provision enabling the present Chairman of the Metropolitan Meat Industry Board constituted under the Meat Industry Act, 1915-1952, to continue in office as a member of that Board until he attains the age of sixty-seven years notwithstanding that under the provisions of that Act as presently enacted members of that Board cease to hold office on attaining the age of sixty-five years.
