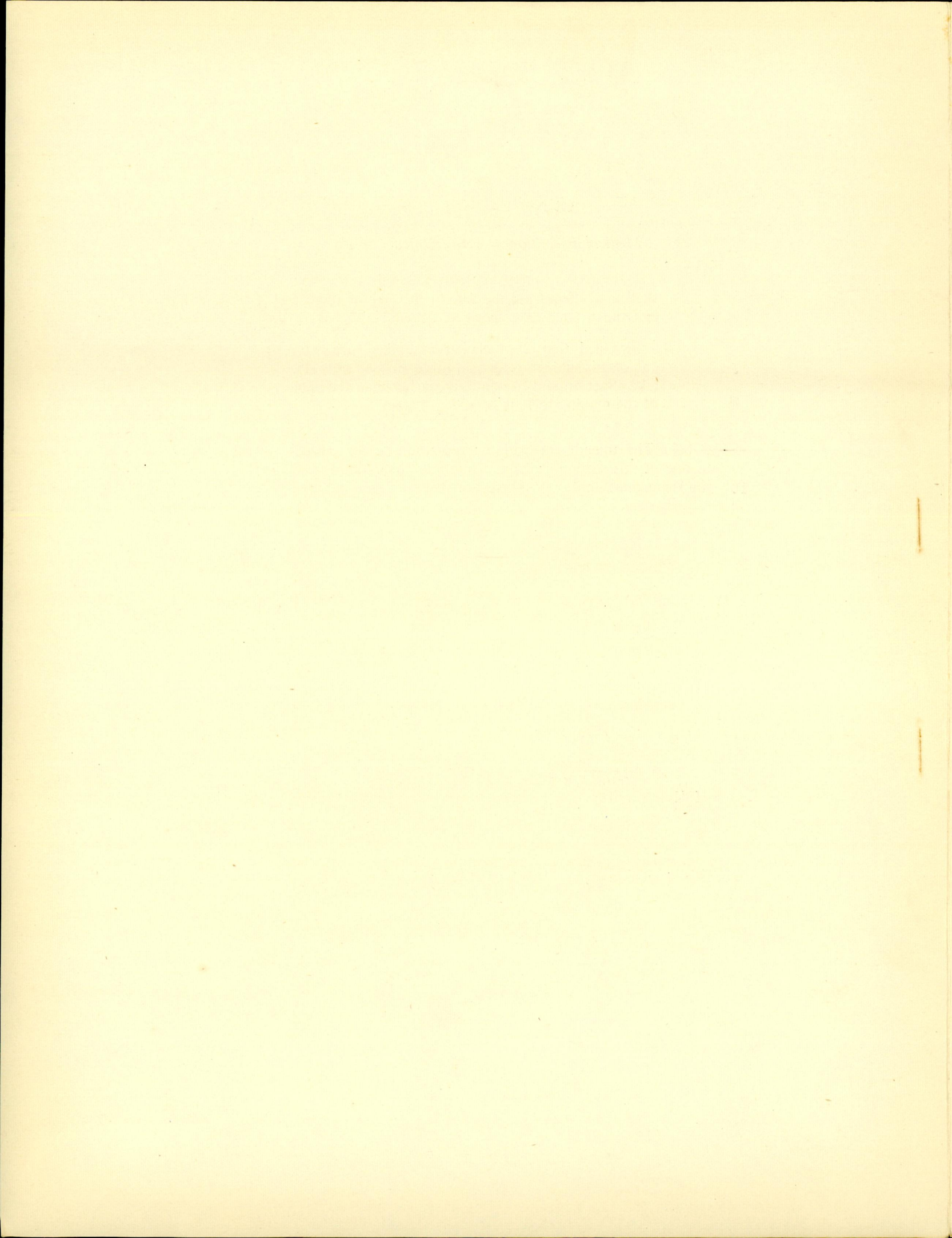

MEDICAL PRACTITIONERS (AMENDMENT) BILL, 1958.

EXPLANATORY NOTE.

THE objects of this Bill are—

- (a) to recognize as registrable qualifications under the Medical Practitioners Act, 1938-1957, certain qualifications obtained in the Republic of Ireland since the formation of that Republic on 18th April, 1949 ;
- (b) to empower the Governor by proclamation to include within the definition of the "British Empire" under that Act any country or part of a country which has at any time been a part of the British Empire.

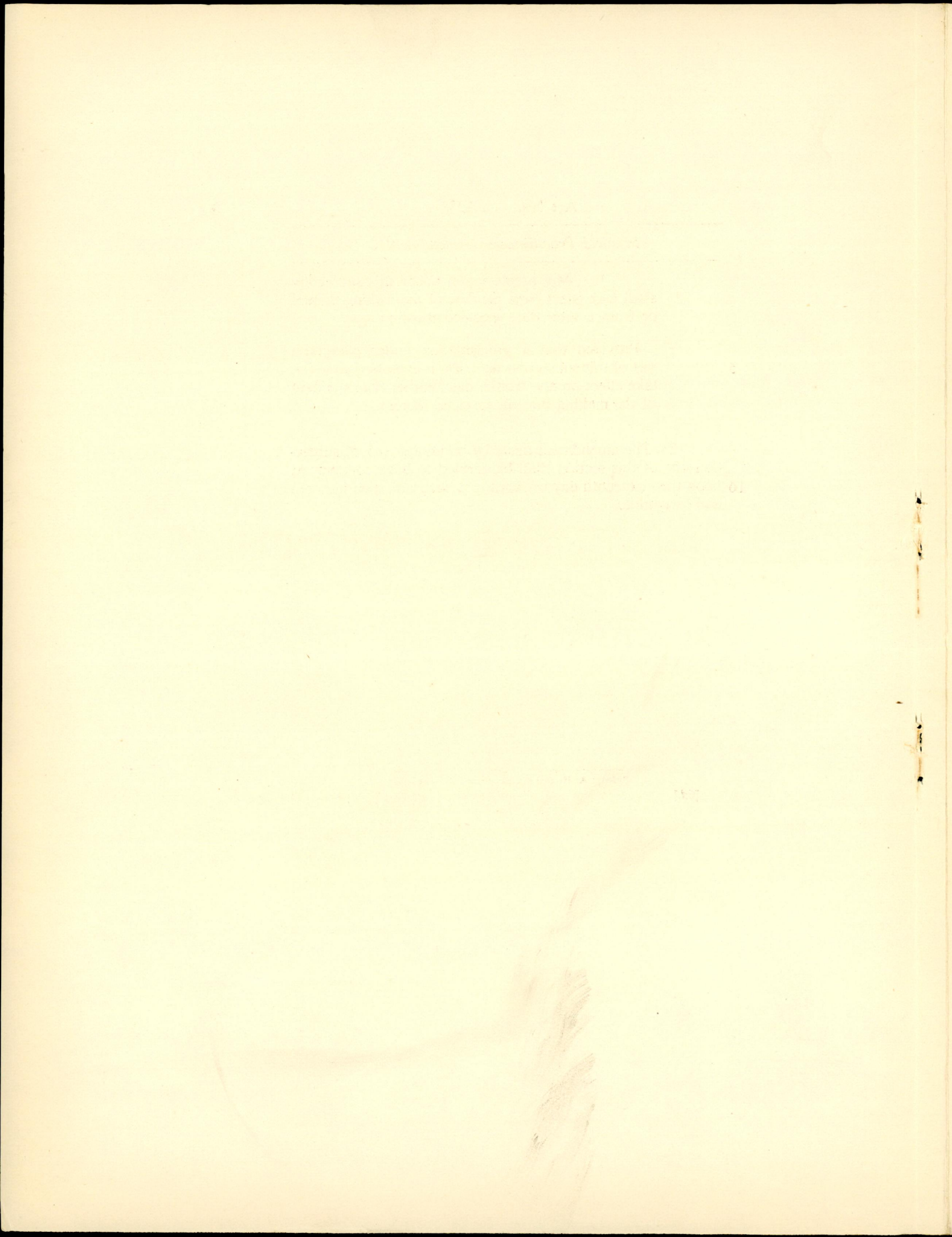

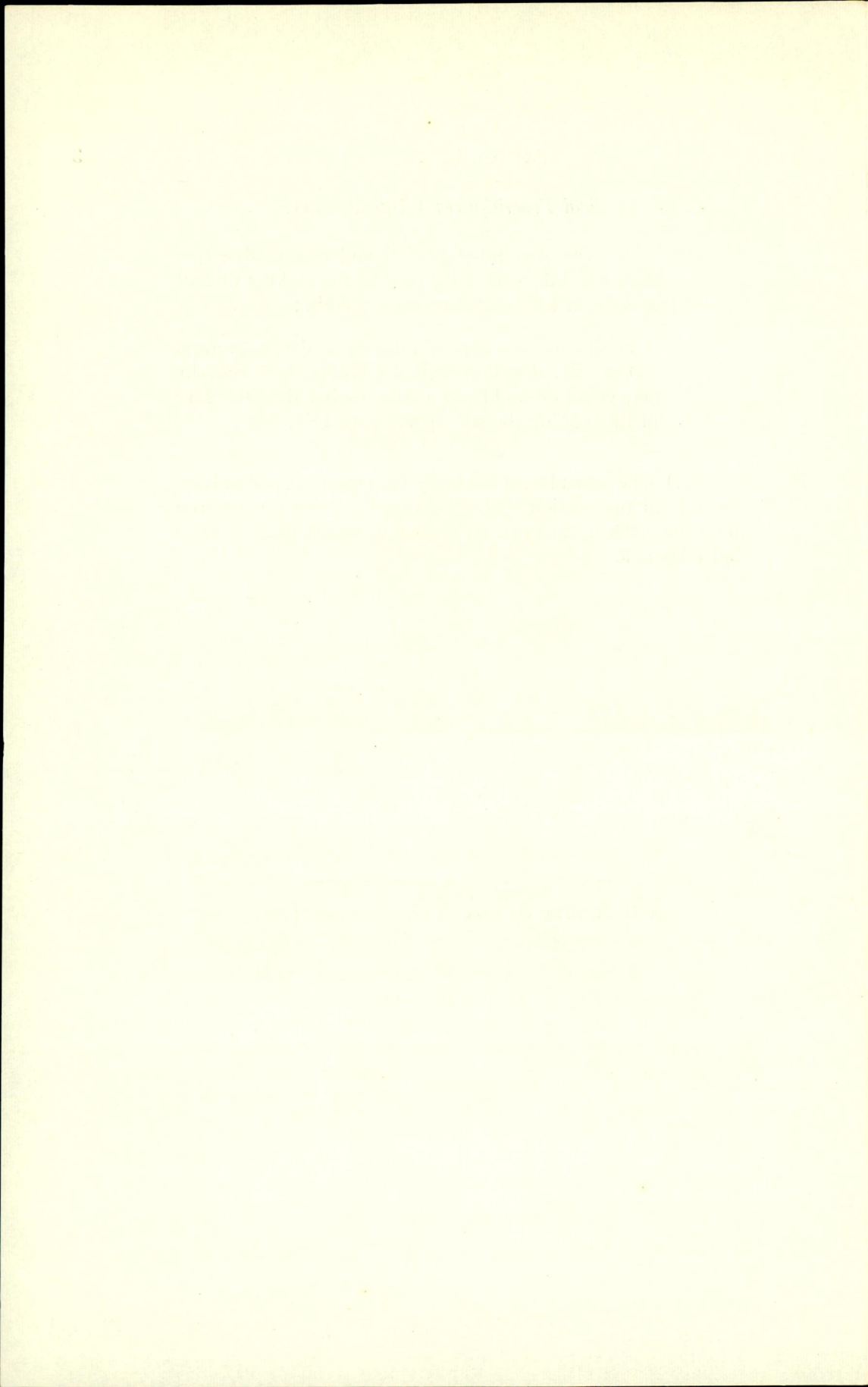
