
EXPLANATORY NOTE.

THE objects of this Bill are-

- (a) to correct the definition of "Poisons List" in section 3 of the Poisons Act, 1952;
- (b) to amend section 11 of that Act by providing that the container in which a poison is sold need only bear the name and address of the seller when the sale is by retail;
- (c) to amend paragraph (d) of subsection one of section 21 of that Act by deleting from the exemption relating to the sale of poison by wholesale dealers in the ordinary course of wholesale dealing the requirement that an order in writing signed by the purchaser must have been given for the supply of the poison;
- (d) to omit subsection four of section 21 (this subsection required sales of certain poisons by wholesale dealers in the ordinary course of wholesale dealing to be recorded in a book kept for the purpose).


