EXPLANATORY NOTE.

THE objects of this Bill are—

- (a) to alter the name of the New South Wales University of Technology to the University of New South Wales;

- (c) to provide that the statement of accounts referred to in section forty-two of the Act and the report of proceedings referred to in section forty-seven of the Act are to be prepared and submitted by the Council to the Minister as soon as practicable after 31st December in each year.
