An Act to provide for the establishment and incorporation of a Wild Dog Destruction Board to exercise and perform the powers, authorities, duties and functions under the Wild Dog Destruction Act, 1921-1950, of the Western Lands Commissioner; for this and other purposes to amend that Act and certain other Acts; and for purposes connected therewith.

Wild Dog Destruction (Amendment).

BE it enacted by the Queen's Most Excellent Majesty,
 by and with the advice and consent of the Legis-
 lative Council and Legislative Assembly of New South
 Wales in Parliament assembled, and by the authority of
 5 the same, as follows:—

1. (1) This Act may be cited as the "Wild Dog
 Destruction (Amendment) Act, 1957." Short title,
 citation and
 commence-
 ment.

(2) The Wild Dog Destruction Act, 1921, as
 amended by subsequent Acts and by this Act, may be
 10 cited as the Wild Dog Destruction Act, 1921-1957.

(3) (a) This Act shall, except as provided in
 paragraph (b) of this subsection, commence upon a day
 to be appointed by the Governor and notified by
 proclamation published in the Gazette.

15 (b) For the purposes only of the constitution
 of the Wild Dog Destruction Board and of any matter
 necessary for or incidental to such constitution, the
 amendment made by section two of this Act shall com-
 mence upon the day upon which the assent of Her
 20 Majesty to this Act is signified. Upon the day appointed
 pursuant to paragraph (a) of this subsection such
 amendment shall have full force and effect for all
 purposes.

3A. (1) There shall be constituted for the purposes

 seal and shall be capable by that name of suing and
 being

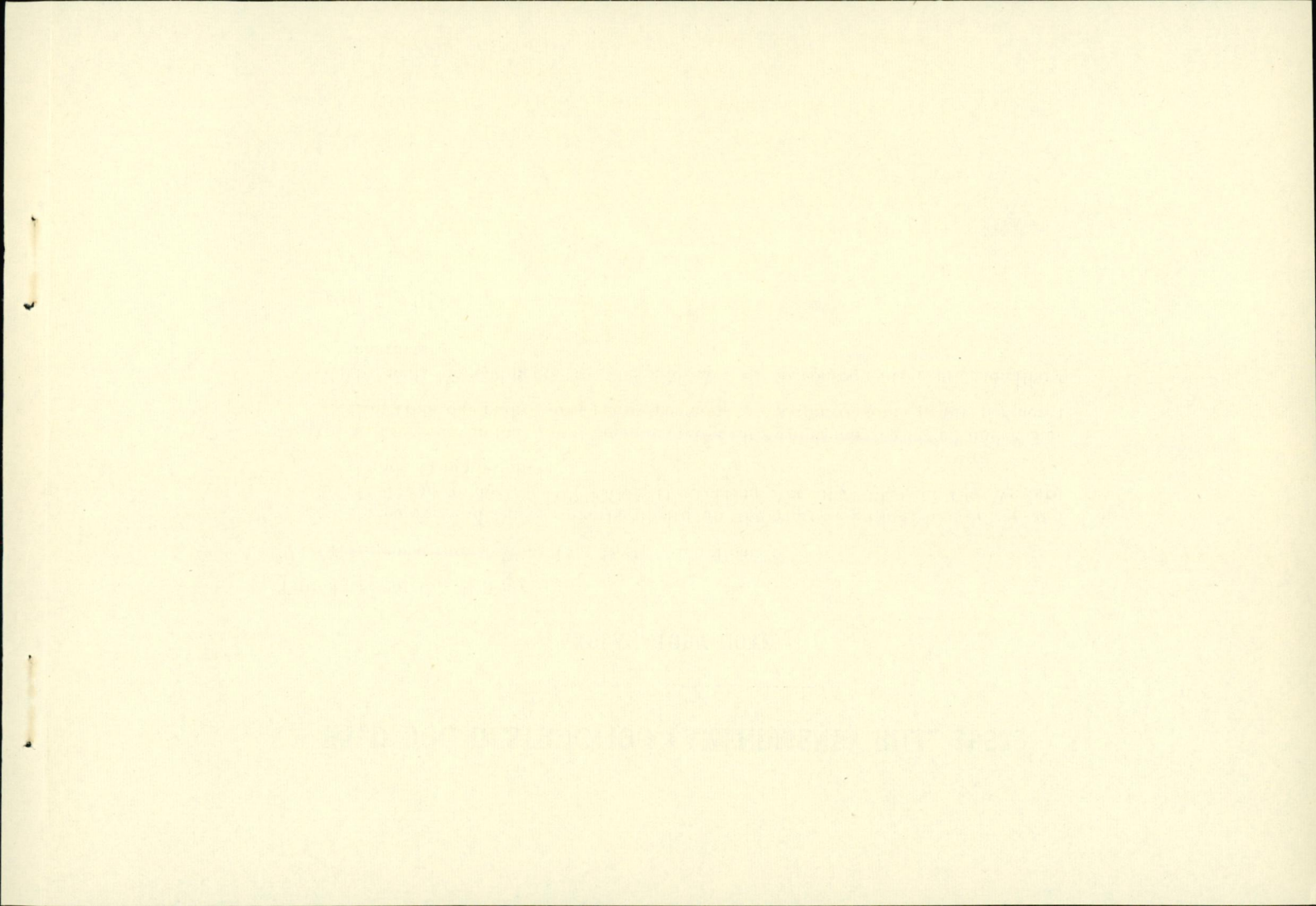

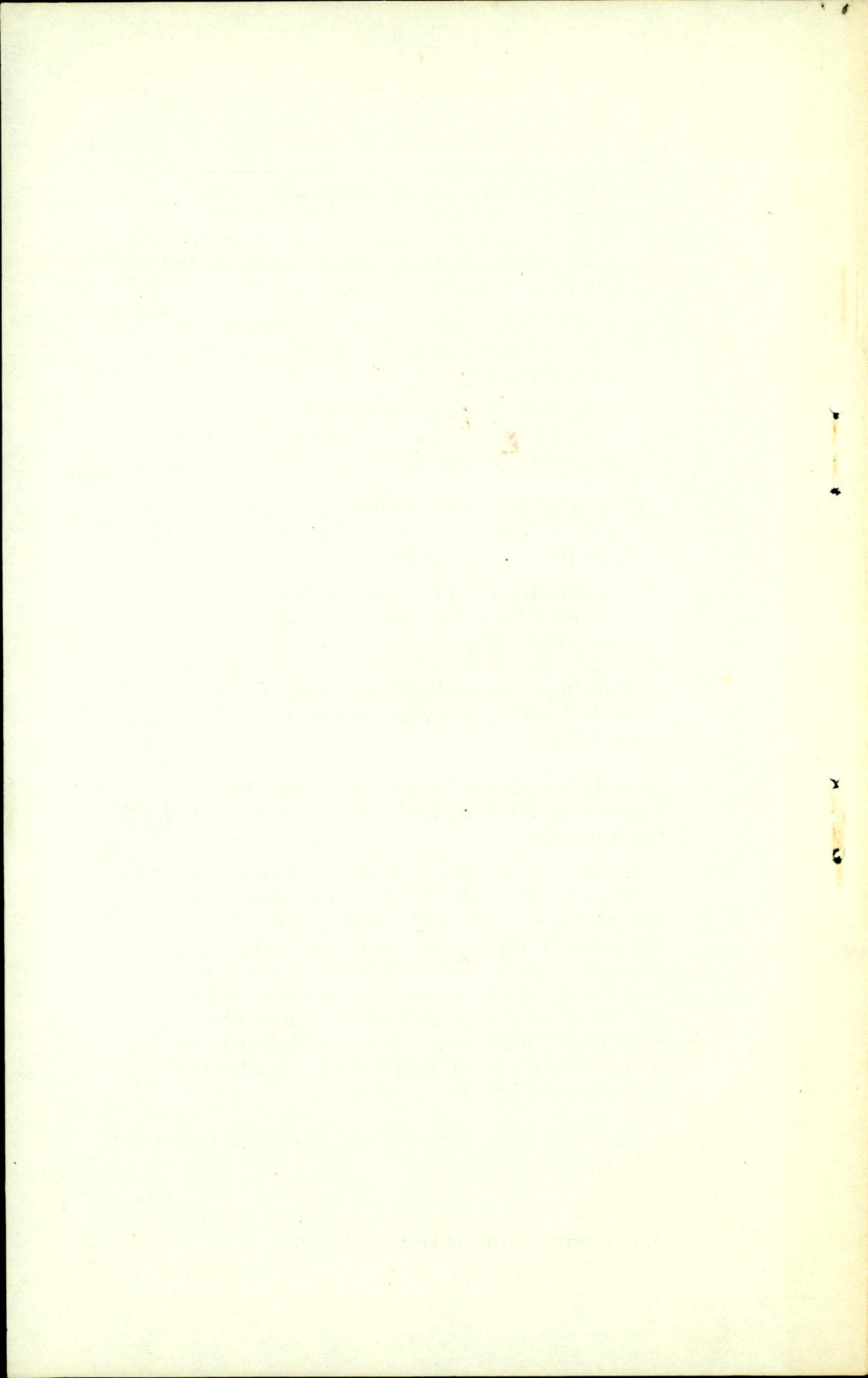

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Wild Dog Destruction (Amendment) Act, 1957."

(2) The Wild Dog Destruction Act, 1921, as amended by subsequent Acts and by this Act, may be cited as the Wild Dog Destruction Act, 1921-1957.

(3) (a) This Act shall, except as provided in paragraph (b) of this subsection, commence upon a day to be appointed by the Governor and notified by proclamation published in the Gazette.

(13) The chairman of the board or in his absence the Assistant Western Lands Commissioner authorised by subsection four of this section to act as chairman shall preside at all meetings of the board and, in the event of an equality of votes, shall have a casting vote as well as a deliberative vote.

(14) No act or proceeding of the board shall be invalidated or prejudiced by reason only of the fact that, at the time such act or proceeding was done, taken or commenced, there was a vacancy in the office of any appointed member.

(15) The appointed members shall be entitled to receive such fees and travelling or other expenses as the Minister may from time to time determine.
