An Act to make further provision for and in relation to closer settlement; for this and other purposes to amend the Closer Settlement Acts, the War Service Land Settlement Act, 1941, and certain other Acts; to validate certain matters; and for purposes connected therewith.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same. as

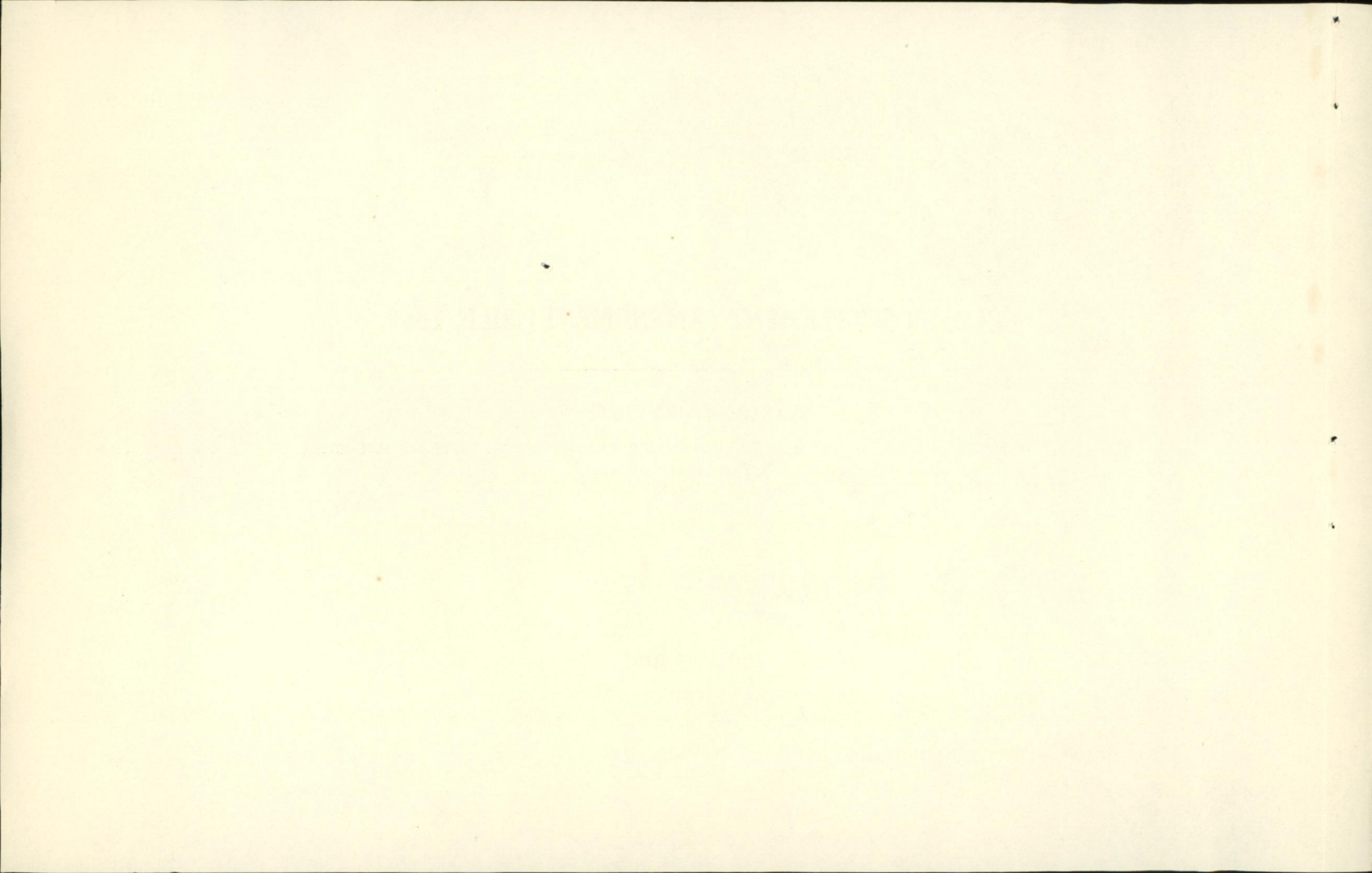
