






CONSTITUTION (LEGISLATIVE COUNCIL ELECTIONS) AMENDMENT BILL, 1960.

EXPLANATORY NOTE.

THE object of this Bill is to enable electors whose sight is so impaired or who are so physically incapacitated that they cannot vote without assistance at elections of Members of the Legislative Council to avail themselves of the assistance of another Member of the Legislative Council or the Legislative Assembly, or of the Clerk of the Parliaments or the Clerk of the Legislative Assembly, according as to whether such elector is a Member of the Legislative Council or Legislative Assembly.
