


## DAIRY INDUSTRY (AMENDMENT) BILL, 1960.

#### **EXPLANATORY NOTE.**

THE object of this Bill is to amend the Dairy Industry Act, 1915-1955, to require:-

- (a) packages of table margarine to be labelled with the words "table margarine" and the name and address of the manufacturer; and
- (b) packages of cooking margarine and margarine, manufactured pursuant to section 22B of the Act, to be labelled with the words "cooking margarine" and the name and address of the manufacturer.


