Act No. , 1960.

An Act to make further provisions with respect to the taking of fish in inland waters; for this purpose to amend the Fisheries and Oyster Farms Act, 1935-1957; and for purposes connected therewith.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the "Fisheries and Oyster Farms (Amendment) Act, 1960".

Fisheries and Oyster Farms (Amendment).

(2) The Fisheries and Oyster Farms Act, 1935, as amended by subsequent Acts and by regulations made under subsection three of section one hundred and twenty of the said Act, as so amended, and by this Act, may be cited as the Fisheries and Oyster Farms Act, 1935-1960.

2. The Fisheries and Oyster Farms Act, 1935-1957, is amended—

- (a) by omitting from the definition of "Inland waters" in subsection one of section four the words "and ponds" and by inserting in lieu thereof the words "ponds, canals, channels and waterways";
- (b) by omitting from subsection four of section 25B the words "under the age of sixteen years" and by inserting in lieu thereof the words "a person, or person belonging to a class of persons, specified in the regulations";
- (c) by omitting paragraph (eee) of subsection two of section one hundred and twenty and by inserting in lieu thereof the following paragraph :—
- (eee) regulating the number of any species of fish any person, other than a holder of a license issued under section twenty-five of this Act, may take, catch, capture or kill or have in his possession in any one day.
