Act No. , 1961.

An Act to provide for the appropriation of a certain sum out of the General Loan Account and for the application of that sum for certain Public Works and Services; and for purposes connected therewith.

WHEREAS the Australian Loan Council at its eighty-fourth meeting held on the fourteenth and fifteenth days of June, one thousand nine hundred and sixty-one, decided in pursuance of Clause 3 (9) of Part I of the Agreement set out in the schedule to the Financial Agreement Act, 1944, that the amount to be borrowed for the loan programmes of the Commonwealth and the States for housing and State works for the financial year ending on the thirtieth day of June, one thousand nine hundred and sixty-two, shall be two hundred and forty million pounds, and by unanimous decision allocated an amount of sixty-two million two hundred and ninety-eight thousand pounds to the State of New South Wales for public works, BE it enacted therefore by the Queen's Most Excellent Majesty, by and with the advice and Preamble.

1. This Act may be cited as the “General Loan Account Short title. Appropriation Act, 1961”.

An Act to provide for the appropriation of a certain sum out of the General Loan Account and for the application of that sum for certain Public Works and Services; and for purposes connected therewith. [Assented to, 22nd November, 1961.]

WHEREAS the Australian Loan Council at its eighty-fourth meeting held on the fourteenth and fifteenth days of June, one thousand nine hundred and sixty-one, decided in pursuance of Clause 3 (9) of Part I of the Agreement set out in the schedule to the Financial Agreement Act, 1944, that the amount to be borrowed for the loan programmes of the Commonwealth and the States for housing and State works for the financial year ending on the thirtieth day of June, one thousand nine hundred and sixty-two, shall be two hundred and forty million pounds, and by unanimous decision allocated an amount of sixty-two million two hundred and ninety-eight thousand pounds to the State of New South Wales for public works, BE it enacted therefore by the Queen's Most Excellent Majesty, by and with the advice and Preamble.

I have examined this Bill, and find it to correspond in all respects with the Bill as finally passed by both Houses.
