## **LIBRARY (AMENDMENT) BILL, 1959.**

### **EXPLANATORY NOTE.**

THE object of this Bill is to increase the maximum subsidy payable by the State to the council of an area in respect of the library services provided by such council under the Library Act, 1939-1952, from one shilling and sixpence for each person resident within such area to three shillings for each person so resident.

LIBRARY (AMENDMENT) BILL, 1959.

EXPLANATORY NOTE

The object of this Bill is to amend the provisions of the Library Act, 1954, in relation to the powers of the Council of the Library Commission to make rules and regulations for the management of the library and to provide for the appointment of a person to be known as the Librarian of the Library Commission.
