An Act to impose a stamp duty on entries made in certain records required to be kept under the Swine Compensation Act, 1928-1958, in lieu of that imposed by the Swine Compensation Taxation Act, 1959; and for purposes connected therewith.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Swine Compensation Taxation Act, 1961" and shall be read and construed with the Swine Compensation Act, 1928-1958.

(2) This Act shall commence upon a day to be appointed by the Governor and notified by proclamation published in the Gazette.

There shall be charged, levied, collected and paid under Stamp duty on certain instruments. 5 and subject to the provisions of the Stamp Duties Act, 1920, as amended by subsequent Acts, upon any instrument specified in the Schedule to this Act the duty specified in the said Schedule for credit of the Swine Compensation Fund established under the Swine Compensation Act, 1928-1958, in 10 lieu of the duty imposed by the Swine Compensation Taxation Act, 1959.
