An Act to make further provisions as to the membership of the University of New South Wales and the Council thereof and financial assistance thereto; for these purposes to amend the Technical Education and University of New South Wales Act, 1949-1958; and for purposes connected therewith.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "University of New South Wales Act, 1961".
(2) Short title and citation.

(2) The Technical Education and New South Wales University of Technology Act, 1949, as amended by subsequent Acts and by this Act, may be cited as the Technical Education and University of New South Wales Act, 1949-1961.

The additional member so appointed shall, subject to the provisions of the Technical Education and University of New South Wales Act, 1949-1961, hold office until the thirtieth day of June, one thousand nine hundred and sixty-five.
