

EXPLANATORY NOTE.

THE objects of this Bill are-

- (a) to provide that a government guarantee may be executed for the repayment of an advance to a permanent building society within the meaning of the Co-operation Act, 1923-1964, without a recommendation of the Co-operative Building Advisory Committee constituted under that Act;
- (b) to provide that any government guarantee in favour of a building society shall not be enforceable against the Treasurer or the Consolidated Revenue Fund until the lender to the society has become entitled to appoint a receiver of such of the property of the society as is charged with the repayment of the debt guaranteed.
