### **EXPLANATORY NOTE.**

THE object of this Bill is to authorise the payment into the Kosciusko State Park Fund of rents received for leases granted under section 11 (3) of the Kosciusko State Park Act, 1944-1952, and certain other moneys received by the Kosciusko State Park Trust, and to validate payments already made into that Fund in respect of such rents and other moneys.
