## MENTAL HEALTH (AMENDMENT) BILL, 1964.

#### EXPLANATORY NOTE.

THE objects of this Bill are—

- (a) to provide that authority similar to that given police officers in relation to mentally ill persons be vested in welfare officers appointed under the Mental Health Act, 1958-1961;
- (b) to authorise the detention of a person in an admission centre under section 12 (1) of the Act not only where the superintendent or medical officer has certified that such person is mentally ill but also where he certifies that such person ought to be detained for further observation or treatment;
- (c) to provide that the medical certificate in the form of Schedule Two of the Act unless used to gain admission of a patient to an admission centre within ten days from the date of its issue shall be ineffective for purposes of admission;
- (d) to permit of entry of police into a residence by using such force as may be necessary for the purposes of the provisions of section twelve of the Act;
- (e) to provide that transfers of patients between hospitals may be arranged by mutual consent of medical superintendents;
- (f) to allow of a reduction in age from twenty-one years to eighteen years of persons who may make application for voluntary admission to admission centres, mental hospitals or authorised hospitals;
- (g) to enable persons to be admitted as voluntary patients on application made orally or in writing;
- (h) to allow of a reduction in age from twenty-one years to eighteen years of voluntary patients who may request the Master to take charge of their estates;

- (5) In this section "patient" includes a voluntary patient.
