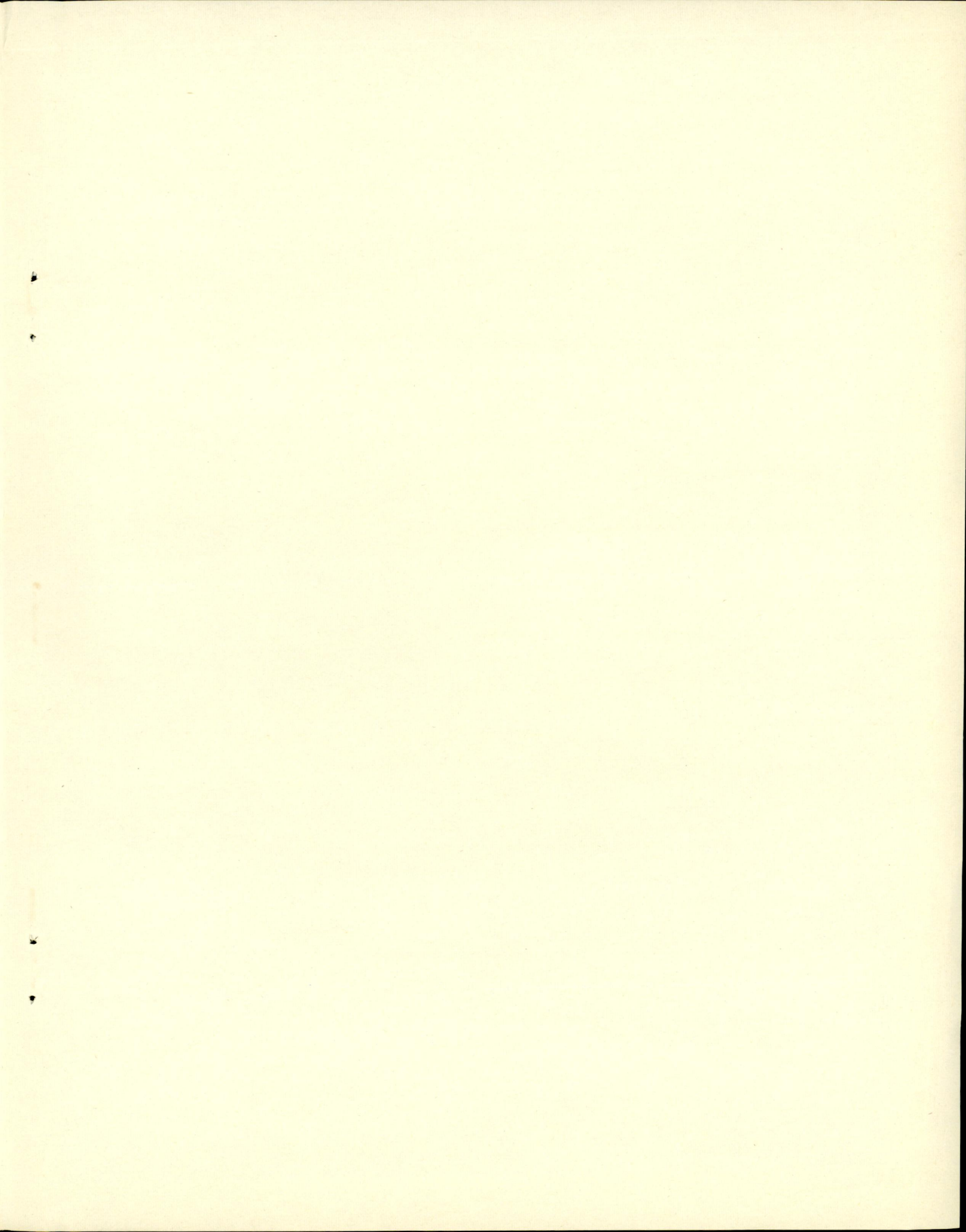

ROYAL BLIND SOCIETY OF NEW SOUTH WALES (AMENDMENT) BILL, 1963.

EXPLANATORY NOTE.

THE objects of this Bill are—

- (a) to allow the Royal Blind Society of New South Wales to demise real property vested in it without the previous sanction of a resolution of a general or special meeting of members;
- (b) to validate titles to certain lands dedicated as the site or as additions to the site for an asylum for the indigent blind and granted by the Crown, notwithstanding the breach or non-performance of any condition, trust or proviso contained in any such grant of such lands and to revoke and annul any condition, trust or dedication affecting such lands;
- (c) to increase from ten pounds sterling to twenty-five pounds the amount of the donation required to constitute a life member of the Society;
- (d) to alter the name of the managing body of the Society from "committee of management" to "council of management";
- (e) to increase the number of members of that managing body from fifteen persons to not more than nineteen persons;
- (f) to make provisions incidental and ancillary to the foregoing.
