B^E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as 5 follows:—

1. (1) This Act may be cited as the "State Planning Short title Authority Act, 1963".

CONSTITUTION OF THE AUTHORITY.

4. (1) (a) There shall be a State Planning Authority of Constitution New South Wales which shall have and may exercise and of discharge the responsibilities, powers, authorities, duties and functions conferred and imposed upon it by or under this or

15 any other Act.

In the exercise and discharge of such responsibilities, powers, authorities, duties and functions the Authority shall, except where the Authority makes a recommendation to the Minister or decides an appeal, be subject in all respects to the 20 control and direction of the Minister.

(b) For the purposes of any Act, the Authority shall be deemed to be a statutory body representing the Crown.

(c) The Authority shall consist of nine fourteen 25 members appointed by the Governor, that is to say—

- (i) two members who shall, in and by the instruments by which they are appointed, be respectively the chairman and the deputy-chairman of the Authority, and one of whom shall possess the qualifications in town planning or country planning prescribed under the Local Government Act, 1919, as amended by subsequent Acts;
- (ii) one member who shall be the Commissioner for Main Roads or an officer of the Department of Main Roads nominated by the Commissioner for Main Roads;

(iii) one member who shall be an officer of a Government Department under the control of the Minister for Transport or statutory body representing the Crown under the control of that Minister and who shall be nominated for such appointment by that Minister;

- (iv) one member who shall be an officer of the Department of Local Government nominated by the person for the time being holding the office of or duly acting as the Under Secretary of that Department;
- (v) one member who shall be nominated by the Minister and shall have such special knowledge and experience in the operation of one or more public utility undertakings as the Minister thinks fit;
- 15 (vi) one member who shall be an officer of a council nominated in the prescribed manner and within the prescribed time by the governing body of the Local Government Association of New South Wales;
- 20 (vii) one member who shall be an officer of a council nominated in the prescribed manner and within the prescribed time by the governing body of the Shires Association of New South Wales:
 - (viii) one member who shall be a member of the Legislative Council or the Legislative Assembly nominated by the Minister.
 - (vi) one member who shall be appointed from a panel of four persons nominated in the prescribed manner and within the prescribed time by the governing bodies of the Royal Australian Institute of Architects (New South Wales Chapter), the Institution of Engineers (Australia), the Institution of Surveyors (Australia) and the Australian Planning Institute (Sydney Division);
 - (vii) four members each of whom shall be an officer of a Council and shall be nominated in the prescribed manner and within the prescribed time by the governing body of the Local Government Association of New South Wales;

(viii) three members each of whom shall be an officer of a Council and shall be nominated in the prescribed manner and within the prescribed time by the governing body of the Shires Association of New South Wales.

(d) In the case of the illness or absence of the chairman, the deputy-chairman shall act in his place, and whilst so acting shall have the immunities, powers, authorities and duties of the chairman.

10 (e) No person shall be concerned to inquire whether or not any occasion has arisen requiring or authorising the deputy-chairman to act in the place of the chairman; and all acts or things done or omitted by the deputy-chairman while so acting as aforesaid shall be as valid and effectual and

15 shall have the same consequences as if they had been done or omitted by the chairman.

(2) (a) A member shall, subject to this Act, be appointed for such term, not exceeding seven years, as may be specified in the instrument of appointment, and, if other-20 wise qualified, be eligible for reappointment from time to

time.

Any such reappointment shall be for such term, not exceeding seven years, as may be specified in the instrument of reappointment.

25 (b) (i) On the occurrence of a vacancy in the office of a member, the Governor may appoint a person having the like qualification (if any) as his predecessor to hold office for the balance of his predecessor's term of office.

(ii) An appointment to fill the vacant office
30 of a member referred to in subparagraph (ii), (iii), (iv), (v) or (viii) of paragraph (c) of subsection one of this section shall be made on the nomination of the person who nominated the member in whose place he is appointed.

(iii) An appointment to fill the vacant office

(c) A person who is of or above the age of sixty-five years shall not be appointed as a member.

(3) If within the prescribed time a panel is not constituted for the purposes of subparagraph (vi) or (vii) (vii)
5 or (viii) of paragraph (c) of subsection one of this section or subparagraph (iii) of paragraph (b) of subsection two of this section, the Governor may appoint an officer of a council nominated by the Minister to be a member of the Authority in lieu of the member required to be appointed from the panel 10 referred to in those subparagraphs.

(4) (a) The chairman and the deputy-chairman shall devote the whole of their time to the duties of their offices and shall receive such annual salaries and allowances as the Governor may from time to time determine.

15 (b) Each member (other than the chairman and deputy-chairman) shall receive such remuneration and allowances as the Governor may from time to time determine.

(c) Where any member not being the chairman or deputy-chairman is an officer of the Public Service or of a 20 statutory body representing the Crown he shall, notwithstanding the provisions of any Act or of any rule or regulation made under any Act, be entitled to receive remuneration and allowances under this section in addition to any remuneration to which he is otherwise entitled.

25 (d) Where by or under any Act provision is made requiring the holder of an office specified therein to devote the whole of his time to the duties of his office, or prohibiting him from engaging in employment outside the duties of his office, such provision shall not operate to disqualify him from

30 holding that office and also the office of a member (but not the office of chairman or deputy-chairman) under this Act, or from accepting and retaining any remuneration and allowances payable to a member under this subsection.

(e) The office of a member (other than the 35 chairman and deputy-chairman) shall not for the purposes of any Act be deemed to be an office or place of profit under the Crown.

(5) The provisions of the Public Service Act, 1902, as amended by subsequent Acts, shall not apply to or in 40 respect of the appointment by the Governor of any member of

of the Authority, and any member so appointed shall not, in his capacity as such member, be subject to the provisions of such Act during his term of office.

(6) (a) Each member before entering upon the duties 5 of his office shall take an oath of allegiance under and in accordance with the provisions of the Oaths Act, 1900, as amended by subsequent Acts, and shall make and subscribe the following declaration of office : ----

I having been appointed a member of The State Planning Authority of 10 New South Wales do hereby declare that I will truly and faithfully fulfil the duties of that office according to the best of my judgment and ability.

(b) If a person, after having been afforded an 15 opportunity of taking such oath of allegiance and making and subscribing such declaration, neglects to do so for a period of one month, or such extended period as the Governor may appoint pursuant to paragraph (c) of this subsection, after the date on which he is appointed, he shall on the expiration of 20 such period of one month, or extended period, as the case may be, be deemed to have declined to accept office.

(c) Where the Governor is satisfied that the delay in taking such oath and making and subscribing such declaration is unavoidable he may extend the time for taking

25 such oath and making and subscribing such declaration for any period not exceeding six months.

(d) Any person who is deemed to have declined to accept office shall not be eligible to be reappointed to fill the vacancy created.

(7) A member shall be deemed to have vacated his 30 office-

- (a) if, being the chairman or the deputy-chairman, he engages in New South Wales during his term of office in any paid employment outside the duties of his office:
- (b) if he dies:

(c) if he becomes bankrupt, compounds with his creditors, or makes any assignment of his salary, remuneration, allowances or estate for their benefit;

(d)

- (d) if, being the chairman or the deputy-chairman, he absents himself from duty for a period exceeding fourteen consecutive days, except on leave granted by the Minister (which leave the Minister is hereby authorised to grant) unless such absence is occasioned by illness or other unavoidable cause;
- (e) if, being a member other than the chairman or the deputy-chairman, he is absent from four consecutive ordinary meetings of the Authority of which reasonable notice has been given him either personally or in the ordinary course of post unless on leave granted by the Authority or unless he is before the expiration of four weeks after the last of such meetings excused by the Authority for his absence from such meetings;
- (f) if he becomes a mentally ill person, a protected person or an incapable person within the meaning of the Mental Health Act, 1958, as amended by subsequent Acts;
- (g) if he is convicted in New South Wales of a felony or of a misdemeanour which is punishable by imprisonment for twelve months or upwards, or if he is convicted elsewhere than in New South Wales of an offence which if committed in New South Wales would be a felony or a misdemeanour which is punishable as aforesaid;
 - (h) if he resigns his office by writing under his hand addressed to the Governor;
 - (i) if he declines office or is deemed to have declined office;
 - (j) if, not being the chairman or the deputy-chairman, he is removed from office by the Governor;
 - (k) if, being one of the members referred to in sub-paragraph (ii), (iii) or (iv) of paragraph (c) of subsection one of this section, he ceases to hold the qualification by virtue of which he was appointed or, being one of the members referred to in subparagraph (i) of that paragraph and having held the qualification referred to in that subparagraph, he ceases to hold that qualification;

- if, being the member referred to in subparagraph (vi) or (vii) (vii) or (viii) of paragraph (c) of subsection one, subparagraph (iii) of paragraph (b) of subsection two, or subsection three, of this section, he ceases to be an officer of a council;
- (m) if, being the member referred to in subparagraph (viii) of paragraph (c) of subsection one of this section, he ceases to be a member of the Legislative Council or the Legislative Assembly, as the case may be.

A member shall be deemed to have vacated his office upon the day upon which he attains the age of sixty-five years.

(8) The Governor may, for any cause which appears to him sufficient, remove any member nominated for appoint-15 ment under paragraph (c) (subparagraph (i) excepted) of subsection one of this section.

(9) (a) The chairman or the deputy-chairman may be suspended from his office by the Governor for misbehaviour or incompetence, but shall not be removed from office except 20 as provided in this subsection.

(b) The Minister shall cause to be laid before Parliament a full statement of the grounds of suspension if Parliament is then in session, and if not, then within seven sitting days after the commencement of the next session.

- 25 (c) The chairman or the deputy-chairman suspended under this section shall be restored to office unless each House of Parliament, within twenty-one days from the time when such statement has been laid before it, declares by resolution that the chairman or the deputy-chairman, as
- 30 the case may be, ought to be removed from office, and if each House of Parliament within the said time does so declare, the chairman or the deputy-chairman, as the case may be, shall be removed by the Governor accordingly.

(10) A person who, at the date of his appointment as
 35 chairman or deputy-chairman, is an officer of the Public Service and who ceases to be chairman or deputy-chairman from any cause whatsoever, otherwise than in pursuance of subsection seven or nine of this section (paragraph (h) of subsection

- 20 chairman or deputy-chairman shall continue to contribute to any fund or account and shall be entitled to receive any deferred or extended leave and any payment, pension or gratuity as if he were an officer or employee within the meaning of the Public Service Act, 1902, the Superannuation
- 25 Act, 1916, or a permanent servant within the meaning of the Local Government and Other Authorities (Superannuation) Act, 1927-1959, as the case may be, or any Act amending such Acts, and for such purpose his service as chairman or deputy-chairman shall be deemed to be service for the purpose 30 of such Acts.

In respect of a chairman or deputy-chairman who is an employee or permanent servant as aforesaid, the Authority shall pay to the State Superannuation Board or the Local Government Superannuation Board, as the case may be, such

- 35 amounts as would have been payable if such chairman or deputy-chairman had remained an employee or permanent servant as aforesaid and had continued to be employed, at the same salary or wages as the salary or wages at which he is employed by the Authority, by the employer by whom

(1) The Authority shall be a body corporate, with Authority perpetual succession and a common seal, and may sue or be to be body corporate—sued in its corporate name, and shall, subject to this Act, be proceedings capable of purchasing, holding, granting, demising, disposing Authority. 5 of or otherwise dealing with real and personal property, and

of doing and suffering all such acts and things as bodies corporate may by law do and suffer.

(2) The corporate name of the Authority shall be "The State Planning Authority of New South Wales".

10 (3) The common seal shall be kept in the custody of the chairman and shall not be affixed to any instrument except in pursuance of a resolution of the Authority.

Any instrument executed in pursuance of any such resolution shall be attested by the signature of any two members.

- 15 (4) (a) The procedure for the calling of meetings of the Authority and for the conduct of business at such meetings shall, subject to this Act and any regulations in relation thereto, be as determined by the Authority.
- (b) The chairman, or in his absence the deputy-20 chairman, shall preside at all meetings of the Authority at which he is present, and in addition to a deliberative vote shall, in the event of an equality of votes, have a second or casting vote.
- (c) Five members, one of whom shall be the 25 chairman or, in his absence, the deputy-chairman, shall form a quorum, and any duly convened meeting at which a quorum is present shall be competent to transact any business of the Authority and shall have and may exercise and discharge all the powers, authorities, duties and functions of the Authority.
- 30 A decision of a majority of the members present at a meeting of the Authority shall be the decision of the Authority.

(5) The Authority shall cause full and accurate minutes to be kept of its proceedings at formal meetings, and35 submit to the Minister a copy of the minutes of each formal meeting within one week after the date on which each such formal meeting is held.

(6) No act or proceeding of the Authority shall be invalidated or prejudiced by reason only of the fact that at the time when such act or proceeding was done, taken or commenced, there was a vacancy in the office of a member.

- 5 (7) (a) No matter or thing done, and no contract entered into by the Authority, and no matter or thing done by any member or by any other person whomsoever acting under the direction of the Authority shall, if the matter or thing was done or the contract was entered into bona fide
- 10 for the purpose of executing this Act, subject them or any of them personally to any action, liability, claim or demand whatsoever.

(b) Nothing in this subsection shall exempt any member from liability to be surcharged with the amount of 15 any payment which is disallowed by the Auditor-General in the accounts of the Authority, and which such member authorised or joined in authorising.

6. (1) The Authority shall appoint and employ such servants. servants as may be necessary for carrying out the provisions20 of this Act.

(2) Subject to the provisions of this Act, every servant of the Authority shall continue in the service of the Authority at the will of the Authority only.

(3) All servants of the Authority shall be subject to25 the sole control and governance of the Authority which may fix wages and conditions of employment where such wages and conditions are not fixed in accordance with the provisions of any other Act.

7. The regulations may make provision—

- (a) for and in relation to the control and governance of servants by the Authority; and

(1) Where a servant of the Authority is guilty of Governance of servants. 8. misconduct or of contravening any regulation made under this Part, or any rule or direction of the Authority, the servant may in accordance with the regulations-

(a) be dismissed or suspended;

but every such servant so dealt with shall be notified in writing of the nature of the misconduct charged or of the breach of regulation, rule or direction alleged to have been 10 committed, and may appeal to the Crown Employees Appeal Board constituted under the Crown Employees Appeal Board Act, 1944, as amended by subsequent Acts, in the manner provided.

PART III.

RESPONSIBILITIES, POWERS, AUTHORITIES, DUTIES AND FUNCTIONS OF THE AUTHORITY.

12. Subject to this Act, the Authority shall be charged Responsi-5 with the responsibility of promoting and co-ordinating bilities, town and country planning and securing the orderly and authorities, economic development and use of land and shall have and duties and may exercise and discharge the following powers, authorities, duties and functions : —

- (a) to submit to the Minister such proposals for the development and use of land and with regard to town and country planning as it considers necessary or appropriate, including proposals for the development and use of land in conjunction with the provision of utility services and public transport facilities;
 - (b) to consider, and furnish reports to and advise and make recommendations to the Minister upon, any matter or proposal relating to the development and use of land or to town and country planning which may be referred to it by the Minister;
 - (c) to carry out research into problems of town and country planning and prepare and issue memoranda, reports, bulletins, maps or plans relating to town and country planning;
 - (d) to advise councils upon all matters concerning the principles of town and country planning and the implementation thereof in local planning schemes;
 - (e) to exercise and discharge such other powers, authorities, duties and functions as are conferred or imposed on it by or under this or any other Act;
 - (f) to do such supplemental, incidental and consequential acts as may be necessary or expedient for the exercise or discharge of its responsibilities, powers, authorities, duties and functions :

CONSTITUTION OF THE AUTHORITY.

 15 any other Act.

In the exercise and discharge of such responsibilities, powers, authorities, duties and functions the Authority shall, except where the Authority makes a recommendation to the Minister or decides an appeal, be subject in all respects to the 20 control and direction of the Minister.

(b) For the purposes of any Act, the Authority shall be deemed to be a statutory body representing the Crown.

(c) The Authority shall consist of nine members 25 appointed by the Governor, that is to say—

- (i) two members who shall, in and by the instruments by which they are appointed, be respectively the chairman and the deputy-chairman of the Authority, and one of whom shall possess the qualifications in town planning or country planning prescribed under the Local Government Act, 1919, as amended by subsequent Acts;
- (ii) one member who shall be the Commissioner for Main Roads or an officer of the Department of Main Roads nominated by the Commissioner for Main Roads;

(iii) one member who shall be an officer of a Government Department under the control of the Minister for Transport or statutory body representing the Crown under the control of that Minister and who shall be nominated for such appointment by that Minister;

- (iv) one member who shall be an officer of the Department of Local Government nominated by the person for the time being holding the office of or duly acting as the Under Secretary of that Department;
- (v) one member who shall be nominated by the Minister and shall have such special knowledge and experience in the operation of one or more public utility undertakings as the Minister thinks fit;
- 15 (vi) one member who shall be an officer of a council nominated in the prescribed manner and within the prescribed time by the governing body of the Local Government Association of New South Wales;
 - (vii) one member who shall be an officer of a council nominated in the prescribed manner and within the prescribed time by the governing body of the Shires Association of New South Wales;
 - (viii) one member who shall be a member of the Legislative Council or the Legislative Assembly nominated by the Minister.

(d) In the case of the illness or absence of the chairman, the deputy-chairman shall act in his place, and whilst so acting shall have the immunities, powers, authorities and duties of the chairman.

30 (e) No person shall be concerned to inquire whether or not any occasion has arisen requiring or authorising the deputy-chairman to act in the place of the chairman; and all acts or things done or omitted by the deputy-chairman while so acting as aforesaid shall be as valid and effectual and

(2) (a) A member shall, subject to this Act, be appointed for such term, not exceeding seven years, as may be specified in the instrument of appointment, and, if otherwise qualified, be eligible for reappointment from time to 5 time.

- 30 (6) (a) Each member before entering upon the duties of his office shall take an oath of allegiance under and in accordance with the provisions of the Oaths Act, 1900, as amended by subsequent Acts, and shall make and subscribe the following declaration of office : —
- 35 I having been appointed a member of The State Planning Authority of New South Wales do hereby declare that I will truly and faithfully fulfil the duties of that office according to the best of my judgment and ability.

(b) If a person, after having been afforded an opportunity of taking such oath of allegiance and making and subscribing such declaration, neglects to do so for a period of one month, or such extended period as the Governor may5 appoint pursuant to paragraph (c) of this subsection, after the date on which he is appointed, he shall on the expiration of such period of one month, or extended period, as the case may be, be deemed to have declined to accept office.

(c) Where the Governor is satisfied that the 10 delay in taking such oath and making and subscribing such declaration is unavoidable he may extend the time for taking such oath and making and subscribing such declaration for any period not exceeding six months.

(d) Any person who is deemed to have declined15 to accept office shall not be eligible to be reappointed to fill the vacancy created.

(7) A member shall be deemed to have vacated his office-

(a) if, being the chairman or the deputy-chairman, he engages in New South Wales during his term of office in any paid employment outside the duties of his office;

(b) if he dies;

(c) if he becomes bankrupt, compounds with his creditors, or makes any assignment of his salary, remuneration, allowances or estate for their benefit;

(d) if, being the chairman or the deputy-chairman, he absents himself from duty for a period exceeding fourteen consecutive days, except on leave granted by the Minister (which leave the Minister is hereby authorised to grant) unless such absence is occasioned by illness or other unavoidable cause;

(e) if, being a member other than the chairman or the deputy-chairman, he is absent from four consecutive ordinary meetings of the Authority of which reasonable notice has been given him either personally or







 - (e) to exercise and discharge such other powers, authorities, duties and functions as are conferred or imposed on it by or under this or any other Act;
 - (f) to do such supplemental, incidental and consequential acts as may be necessary or expedient for the exercise or discharge of its responsibilities, powers, authorities, duties and functions :

Provided that nothing contained in this section shall be deemed to empower the Authority to determine that any rural land shall or shall not be used for any particular agricultural or pastoral purpose.

STATE PLANNING AUTHORITY BILL, 1963.

EXPLANATORY NOTE.

THE objects of this Bill are-

- (a) to set up a State Planning Authority of New South Wales consisting of nine members, namely—
 - (i) a chairman and a deputy-chairman who shall be full-time members and one of whom shall possess town planning qualifications; and
 - (ii) seven part-time members comprising the Commissioner for Main Roads or his officer, an officer nominated by the Minister for Transport, an officer of the Department of Local Government, a member having special knowledge and experience in the operation of public utility undertakings, one member appointed from three officers of councils nominated by the Local Government Association, one from three such officers nominated by the Shires Association and one member who shall be a member of the Legislative Council or the Legislative Assembly;
- (b) to charge the State Planning Authority, subject to the control and direction of the Minister, with the responsibility of promoting and co-ordinating town and country planning and securing the orderly and economic use and development of all land; and for this purpose, to confer upon the State Planning Authority the following powers, authorities, duties and functions:—
 - (i) to submit proposals to the Minister for the development and use of land and with regard to town and country planning;
 - (ii) to report to and make recommendations to the Minister upon matters referred to it by the Minister with regard to the development and use of land or town and country planning;
 - (iii) to advise councils upon matters concerning town and country planning principles and their implementation in local planning schemes;
 - (iv) to acquire land by way of lease, purchase, appropriation or resumption, to enable the State Planning Authority to carry out its developmental functions and its functions as a responsible authority under Part XIIA of the Local Government Act, 1919, as amended by subsequent Acts;
 - (v) to sell land, subject to the approval of the Minister;
 - (vi) to exercise and discharge certain other powers, authorities, duties and functions as are conferred or imposed on it under this or any other Act;
- (c) to constitute regional planning districts and regional planning committees to report to and advise the State Planning Authority on any planning matters affecting the regional planning districts;
- (d) to abolish The Cumberland County Council and transfer its assets, liabilities and staff to the State Planning Authority;
- (e) to abolish The Northumberland County Council and transfer its assets, liabilities and staff to the State Planning Authority;

- (f) to transfer certain officers and employees employed in the Department of Local Government to the Authority;
- (g) to make provision with respect to certain leave and superannuation rights of persons transferred to the service of the State Planning Authority;
- (h) to establish a State Planning Authority Account in the Special Deposits Account at the Treasury, and to require the State Planning Authority to create a General Fund and a Trust Fund, as well as a development fund in respect of each development area referred to in paragraph (i) below, and to define the assets of, and authorise the application of the moneys in, each such fund;
- (i) to constitute the Cumberland Development Area and the Northumberland Development Area, and to make provision for the constitution of other development areas from time to time;
- (j) to require councils of the areas within the Metropolitan, Northumberland and Wollongong districts specified in the Second Schedule to the Act to give effect to this Bill to contribute each year to the General Fund of the State Planning Authority an amount not exceeding one-tenth of a penny in the pound on the unimproved capital value of all ratable land within their areas;
- (k) to empower the Treasurer to contribute each year to the General Fund of the State Planning Authority an amount equal to one-fourth of the contributions made by the councils or £100,000, whichever is the lesser;
- (1) to empower the State Planning Authority, with the approval of the Governor, to borrow moneys;
- (m) to require the State Planning Authority to keep, audit and present accounts;
- (n) to amend Part XIIA of the Local Government Act, 1919, as amended by subsequent Acts—
 - (i) to confer upon the State Planning Authority certain of the functions at present performed by the Minister and the Town and Country Planning Advisory Committee under that Part;
 - (ii) to abolish the Town and Country Planning Advisory Committee;
 - (iii) to authorise the Minister to direct the State Planning Authority to prepare planning schemes;
 - (iv) to clarify provisions relating to compensation-
 - (a) where land is zoned or reserved so that compensation is payable only where land is zoned for certain public purposes;
 - (b) where land is injuriously affected by a restriction which could be lawfully imposed (other than in a planning scheme) without incurring any liability to pay compensation:
 - (v) to provide that compensation shall not be payable in respect of any provision of a scheme requiring, or enabling to be required, the provision of parking, loading and unloading space for vehicles;
 - (vi) to allow an extension of time for lodgment of claims to be granted by a judge of the Land and Valuation Court in accordance with rules of court;
- (o) to make other provisions consequent upon and ancillary to the foregoing.

Any instrument executed in pursuance of any such resolution shall be attested by the signature of any two members.

(4) (a) The procedure for the calling of meetings of the Authority and for the conduct of business at such meetings10 shall, subject to this Act and any regulations in relation thereto, be as determined by the Authority.

(b) The chairman, or in his absence the deputychairman, shall preside at all meetings of the Authority at which he is present, and in addition to a deliberative vote 15 shall, in the event of an equality of votes, have a second or casting vote.

(c) Five members, one of whom shall be the chairman or, in his absence, the deputy-chairman, shall form a quorum, and any duly convened meeting at which a quorum 20 is present shall be competent to transact any business of the Authority and shall have and may exercise and discharge all the powers, authorities, duties and functions of the Authority.

A decision of a majority of the members present at a meeting of the Authority shall be the decision of the 25 Authority.

(5) The Authority shall cause full and accurate minutes to be kept of its proceedings at formal meetings, and submit to the Minister a copy of the minutes of each formal meeting within one week after the date on which each such 30 formal meeting is held.

(6) No act or proceeding of the Authority shall be invalidated or prejudiced by reason only of the fact that at the time when such act or proceeding was done, taken or commenced, there was a vacancy in the office of a member. (7)

 - (e) to exercise and discharge such other powers, authorities, duties and functions as are conferred or imposed on it by or under this or any other Act;
 - (f) to do such supplemental, incidental and consequential acts as may be necessary or expedient for the exercise or discharge of its responsibilities, powers, authorities, duties and functions.

(4) The members of a regional planning committee, not being a member or servant of the Authority, shall be entitled to receive such remuneration (whether by way of 20 fee or allowance or otherwise) and such travelling expenses as may from time to time be fixed by the Authority.

(5) Where any member of a regional planning committee is an officer of the Public Service or of a statutory body representing the Crown (not being the Authority), he shall,

(d) In the case of the illness or absence of the 30 chairman, the deputy-chairman shall act in his place, and whilst so acting shall have the immunities, powers, authorities and duties of the chairman.

(e) No person shall be concerned to inquire whether or not any occasion has arisen requiring or authoris-35 ing the deputy-chairman to act in the place of the chairman; and all acts or things done or omitted by the deputy-chairman while so acting as aforesaid shall be as valid and effectual and shall have the same consequences as if they had been done or omitted by the chairman.

(2) (a) A member shall, subject to this Act, be appointed for such term, not exceeding seven years, as may be specified in the instrument of appointment, and, if otherwise qualified, be eligible for reappointment from time to 5 time.

(f) to do such supplemental, incidental and consequential acts as may be necessary or expedient for the exercise or discharge of its responsibilities, powers, authorities, duties and functions.

(3) Any person when acting within the scope of any such delegation to him shall be deemed to be the Authority.
