




SYDNEY HARBOUR BRIDGE (ADMINISTRATION) AMENDMENT BILL, 1962.

EXPLANATORY NOTE.

THE objects of this Bill are-

- (a) to include in the definition of the Warringah Expressway Approach the proposed road from Ernest Street to Miller Street;
- (b) to enable the Sydney Harbour Bridge Account to be utilised for the purposes of bearing the cost of the construction of such Approach;
- (c) to vest the administration of such Approach in the Commissioner for Main Roads;
- (d) to make provisions consequential upon and incidental to the foregoing.
