- (j) that the licensee has unreasonably failed, or unreasonably refused, to satisfy an award made by the Commission against an employer insured or indemnified by the licensee against the liability of the employer thereunder;
- (k) that the conduct of the licensee, his employees, and officers, and the arrangement of his affairs have been such that, in the opinion of the Commission, he should not continue to hold a license.
- (2) For the purposes of this section a licensee shall be deemed to be unable to pay his debts if—
- (a) a creditor by assignment or otherwise to whom the licensee is indebted in a sum exceeding fifty pounds then due has served on the licensee by leaving at his usual place of business or if such licensee is a corporation at the registered office thereof a demand under his hand or under the hand of his agent thereunto lawfully authorised requiring the licensee to pay the sum so due, and the licensee has for three weeks thereafter neglected to pay the sum or to secure or compound for it to the reasonable satisfaction of the creditor; or
 - (b) execution or other process issued on a judgment, decree or order of any court in favour of a creditor of the licensee is returned unsatisfied in whole or in part; or
 - (c) it is proved to the satisfaction of the Commission that the licensee is unable to pay his debts and in determining whether a licensee is unable to pay his debts the Commission

Commission shall take into account the accrued, continuing, future and contingent liabilities of the licensee.

(3) (a) Proceedings on any ground specified in subsection one of this section or subsection seven of section 18c of this Act for the suspension or termination of a license or for limiting or varying the period of a license or attaching any conditions thereto or varying the conditions thereof shall be instituted by application by the Registrar in the form and manner prescribed by rules made under this Act, setting forth the ground or grounds of the application, and thereupon the Commission shall give notice in such form and manner as is so prescribed to the licensee mentioned in such application calling upon him to show cause why his license should not be dealt with as aforesaid.

WORKERS' COMPENSATION (AMENDMENT) BILL, 1964.

EXPLANATORY NOTE.

THE objects of this Bill are to amend the Workers' Compensation Act, 1926-1962-

- (1) to increase from £10 10s. 0d. to £11 15s. 0d. the maximum weekly compensation payable, in addition to allowances for dependants, to a worker whilst incapacitated by injury; to increase from £3 0s. 0d. to £3 3s. 0d. the weekly compensation payable in respect of the dependent wife of a worker so incapacitated; and to increase certain other rates of compensation;
- (2) to provide for the payment of compensation at the rate of £1 5s. 0d. per week during incapacity to a worker in respect of each dependent child over 16 but under 21 years of age who is a full time student at a university, college or school;
- (3) to entitle a worker to payment of weekly compensation in respect of incapacity from an injury notwithstanding that he has been paid or has claimed lump sum compensation for that injury under section sixteen of the Act;
- (4) to prescribe lump sum compensation for-
 - (a) total or partial loss of the power of speech;
 - (b) severe facial disfigurement;
- (5) to include in the definition of "medical treatment" treatment by a remedial medical gymnast;
- (6) by omitting the provisions limiting to a maximum of four the number of persons who may be appointed as members of the Workers' Compensation Commission and enabling the appointment of such number of members, not being less than three, as may from time to time be determined;
- (7) to provide that incapacity for a particular employment shall be deemed to have arisen if the employment is of such a nature that the worker cannot engage therein without immediate and substantial danger of injury;
- (8) to provide that the maximum compensation payable to a partially incapacitated worker shall be the difference between the amount he would probably have been earning as wages but for the injury and the amount he is in fact earning or able to earn;
- (9) to provide that a person acting for fee or reward as a boxer, wrestler or referee in a contest held in the premises of a registered club shall be deemed to be a worker;

- (10) to provide that for the purposes of the "journeying" provisions of the Act a worker's journeys to and from his place of abode shall be deemed to commence and terminate at the external entrance of the building or individual flat in which he resides instead of, as at present, the outer boundary of the curtilage;
- (11) to entitle a worker to compensation for damage to his spectacle glasses, artificial teeth, artificial aids and the like, and to his clothing, which results from an accident occurring in the course of a journey to which the "journeying" provisions apply;
- (12) to enable a person who has rendered medical service to a worker in respect of a compensable injury to recover payment for that service direct from the employer;
- (13) to confer on the Workers' Compensation Commission more extensive powers than it now has in relation to the licensing of insurers and self-insurers;
- (14) to require an employer to keep posted at his business premises a statement showing the name of the insurer with whom he is insured against liability pursuant to the Act;
- (15) to require an employer of a worker, at the request of the worker or the worker's solicitor or union representative, to produce for inspection any insurance policy obtained by the employer pursuant to the Act and applicable to the employment;
- (16) to require an employer who has taken out an insurance policy pursuant to the Act to keep certain records in relation to wages paid to his workers, and to enable the Workers' Compensation Commission to make orders—
 - (a) requiring an employer to furnish particulars of wages so paid, and to produce such records; and
 - (b) for the payment of any premium held to be payable to the insurer in respect of the policy;
- (17) in relation to the Uninsured Liability Scheme by-
 - (a) removing the limit of £10,000 on the aggregate annual disbursements under the Scheme, and validating payments made since the 1st July, 1961, in excess of that limit;
 - (b) enabling a worker to make an application under the Scheme concurrently with his application for an award of compensation against the the employer;
- (c) enabling a worker to apply for and obtain an award of compensation, operating only as a basis for an application under the Scheme, against his uninsured employer being a company in liquidation or under official management without his first obtaining the leave of the Supreme Court; and
 - (d) providing that payments under the Scheme shall include the costs of the worker's application for such payments;

- (18) (a) to increase from twelve months to two years the time within which a prosecution against an employer for failure to take out a policy of insurance may be commenced, and
 - (b) to provide that in such a prosecution proof that the employer has failed to comply with a notice by the Commission or an authorised officer to produce a policy of insurance shall be evidence, unless the contrary be proved, that he has failed to take out such a policy;
- (19) to provide that on the death of an insured employer his rights against the insurer under the policy of insurance shall be transferred to and vest in his workers;
- (20) in relation to bush fire fighters' compensation by-
 - (a) providing that compensation shall in certain cases be paid in respect of injury to a fire fighter or destruction of or damage to his property where the injury or damage is sustained in a fire district constituted under the Fire Brigades Act, 1909, as amended;
 - (b) providing that the fund for payments of such compensation shall in future be financed by the transfer from time to time of amounts from the Eastern and Central Divisions Bush Fire Fighting Fund constituted under the Bush Fires Act, 1949-1958; and
 - (c) increasing from £10 to £25, or such greater sum as may be prescribed in respect of damage to workers' clothing under the general provisions of the Act, the maximum compensation payable for damage to the wearing apparel or personal effects of a bush fire fighter, and providing for payment of compensation to such a fighter for damage to his spectacle glasses, artificial teeth, artificial aids, and the like;
- (21) to repeal section 46 (4) which excludes from the operation of the Act (except to the extent prescribed) members of the crew of a fishing vessel remunerated wholly or mainly by shares in the profits of the gross earnings of the working of such vessel;
- (22) to provide retrospectively that an order made pursuant to the Crimes Act, 1900, as amended, for the payment of compensation to a worker for loss or damage caused by the commission of a crime or offence which has resulted in an injury shall not be a bar to his recovery of workers' compensation for that injury, except to the extent of any amount paid pursuant to such order;
- (23) to enable a worker to apply for and recover compensation notwithstanding that he is under 21 years of age;
- (24) to provide that applications for compensation by a worker or his dependants against two or more persons alleged to have employed him at the same or different times shall, if made in respect of the same injury or incapacity or the death of the worker and if the applicant so requests, be heard together:

- (25) to overcome certain effects of the decision of the High Court in the case of Fisher v. Hebburn Limited (105 C.L.R. 188), in particular by providing that the test of dependency shall be dependence upon the worker for support instead of, as at present, dependence upon the worker's earnings, such amendments having retrospective effect; and
- (26) to make certain provisions ancillary and supplemental to the foregoing.

The Workers' Compensation (Broken Hill) Act, 1920-1964, is to be amended by providing for increases in compensation comparable to those provided in this Bill for workers under the Workers' Compensation Act and to include a student child as a dependant.

The Common Law Procedure Act, 1899-1964, is to be amended to provide that interest on the amount of a verdict obtained in the Supreme Court by a worker in respect of an injury to him shall be payable only on that part of the amount which remains after the deduction of workers' compensation already paid to him in respect of that injury.

An Act to amend the law relating to workers' compensation; to amend the Workers' Compensation Act, 1926, the Workers' Compensation (Silicosis) Act, 1942, the Workmen's Compensation (Broken Hill) Act, 1920, the Common Law Procedure Act, 1899, and certain other Acts in certain respects; to validate certain matters; and for purposes connected therewith. [Assented to, 16th December, 1964.]

B^E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title, citation and commencement.

- 1. (1) This Act may be cited as the "Workers' Compensation (Amendment) Act, 1964".

The period to be specified in the order shall be a period when the policy was in force and which commenced not more than three years before the making of the application;
 - (ii) to make available at or within such time or times and at such place as is specified in the order, for inspection by—
 - (a) an officer authorised in that behalf by the Commission;
 - (b) a person authorised in that behalf by the insurer and so specified,

the records required by this subsection to be kept by the employer and at the time of the order to be retained by him in respect of a period so specified, being a period when the policy was in force.

- (c) Any officer or person authorised under subparagraph (ii) of paragraph (b) of this subsection may inspect such records in accordance with the terms of the order and make copies thereof and take extracts therefrom.
- (d) The Commission on application by an insurer on whose application an order has been made against an employer under paragraph (b) of this subsection may order the employer to pay to the insurer such amount as the Commission may having regard to the operation of this subsection find to be due and payable as a premium or balance of premium in respect of a policy of insurance or indemnity or any renewal thereof.

 - (ii) to make available at or within such time or times and at such place as is specified in the order, for inspection by—
 - (a) an officer authorised in that behalf by the Commission;
 - (b) a person authorised in that behalf by the insurer and so specified,

- (iv) that a person claiming to be a creditor by assignment or otherwise of such licensee or corporation for a sum exceeding fifty pounds then due has served on such licensee or corporation by leaving at its registered office a demand under his hand or under the hand of his agent thereunto lawfully authorised requiring such licensee or corporation to pay the sum so claimed to be due, and such licensee or corporation has for three weeks thereafter failed to pay the sum or to secure or compound for it to the satisfaction of the person claiming to be a creditor;
- (v) the return unsatisfied in whole or part of execution or other process issued on a judgment, decree or order of any court in favour of a creditor of such licensee or corporation;
- (vi) the receipt by such licensee or corporation, or the giving, or causing to be given by such licensee or corporation, of any notice or statement mentioned in subsection two of section one hundred and eighty-four of the Companies Act, 1961, as amended by subsequent Acts;

- (vii) the making of an order for the winding-up of such licensee or corporation by any court;

Termination of licenses.

(1) Subject to the provisions of this section the Commission may suspend, or terminate, any license granted under section twenty-seven of this Act, or limit, or vary the period thereof, or attach any conditions thereto, or vary the conditions thereof, if it is satisfied of one or more of the following matters, events or things:—

 - (b) that the licensee being a corporation has resolved that it be wound up voluntarily or by a court;

- (ii) that it is in the interests of the public or of the shareholders or of the creditors that the company should be wound up;
- (e) that the licensee has failed to comply with any provision of this Act and such failure constitutes a substantial breach of the requirements of this Act;
- (f) that the licensee has been guilty of repeated breaches of this Act, whether of the same kind or of different kinds;
- (g) that the licensee has failed to arrange suitable and adequate reinsurance of liabilities undertaken by him under policies of insurance or indemnity issued by him;
- (h) that the licensee has failed to make suitable and adequate provision for his accrued, continuing, future, and contingent liabilities under policies of insurance or indemnity issued by him;
- (i) that the licensee has failed to comply with the conditions of his license;

- (j) that the licensee has unreasonably failed, or unreasonably refused, to satisfy an award made by the Commission against an employer insured or indemnified by the licensee against the liability of the employer thereunder;
- (k) that the conduct of the licensee, his employees, and officers, and the arrangement of his affairs have been such that, in the opinion of the Commission, he should not continue to hold a license.
- (2) For the purposes of this section a licensee shall be deemed to be unable to pay his debts if—
 - (a) a creditor by assignment or otherwise to whom the licensee is indebted in a sum exceeding fifty pounds then due has served on the licensee by leaving at his usual place of business or if such licensee is a corporation at the registered office thereof a demand under his hand or under the hand of his agent thereunto lawfully authorised requiring the licensee to pay the sum so due, and the licensee has for three weeks thereafter neglected to pay the sum or to secure or compound for it to the reasonable satisfaction of the creditor; or
 - (b) execution or other process issued on a judgment, decree or order of any court in favour of a creditor of the licensee is returned unsatisfied in whole or in part; or
 - (c) it is proved to the satisfaction of the Commission that the licensee is unable to pay his debts and in determining whether a licensee is unable to pay his debts the Commission

Commission shall take into account the accrued, continuing, future and contingent liabilities of the licensee.

(2) Any person hindering or preventing a person authorised thereto by such order from inspecting or making copies of or extracts from any such books, documents, papers or records and any licensee or any employee of the licensee named or designated in any such order who refuses or neglects to produce any such books, documents, papers or records in accordance with any such order, shall be guilty of an offence against this Act.

Records and notifications.

- 30c. (1) The Commission shall keep records in relation to all licenses which records shall include particulars of the granting, refusal, duration, suspension and termination of licenses, the conditions thereof and such other matters pertaining thereto as the Commission may think fit.
- (2) A certificate purporting to be signed by the Registrar or deputy or assistant registrar of the Commission or other prescribed officer certifying that on any date or during any period specified in the certificate the particulars set forth in the certificate as to any of the matters specified or referred to in subsection one of this section did or did not appear on or from such records shall, in all courts and upon all occasions whatsoever, without proof of the signature or of the official character of the person purporting to have signed the certificate and without the production of any record or document upon which the certificate is founded, be prima facie evidence of the particulars certified in and by the certificate.
- (3) An applicant for a license shall if so required by the Commission give such notice of his application by advertisement or otherwise as the Commission may determine and if he fails to do so the application shall be deemed not to have been duly made.

- (4) The Commission shall cause notification of every suspension or termination of a license to be published in the Gazette.
- 30p. (1) (a) A license which has been ter-penalties. minated or the period of which has expired or which is for the time being suspended shall be deemed not to be in force.
- (b) Every person who carries on the business of insurance of employers against their liability to their workers under this Act, or independently of this Act, for injuries to their workers, shall unless a license has been granted to him under section twenty-seven of this Act and is for the time being in force be guilty of an offence against this Act and be liable to a penalty not exceeding five hundred pounds for every day during which such business is carried on.
- (2) Every person who commits an offence under this Part of this Act shall where no other pecuniary penalty is provided be liable to a penalty not exceeding two hundred pounds or imprisonment for a term not exceeding six months, and after the date of conviction of any such offence shall from time to time be liable to further penalties not exceeding fifty pounds for every week during which he continues to commit the offence.
- 30E. No contract of insurance or indemnity and Saving of no term or condition thereof shall be void or policies. unenforceable by reason only of the fact that the person issuing the policy was not licensed pursuant to section twenty-seven of this Act or that the issue thereof by a person so licensed was contrary to the conditions of his license.
