EXPLANATORY NOTE

THE objects of this Bill are-

- (a) to make further provision with respect to crimes committed on or about aircraft;
- (b) to confer on the commander of an aircraft, in certain circumstances, power to arrest, restrain, keep in custody or remove from an aircraft, another person;
- (c) to confer on the commander of an aircraft, or a person authorised for the purpose by a Justice, power to search the aircraft, persons, luggage and freight, in certain circumstances;
- (d) except in the case of certain serious crimes, to empower a Court to impose a fine in addition to deferring or suspending sentence upon an offender convicted on indictment entering into a recognizance to be of good behaviour;
- (e) to remove certain restrictions on the imposition of cumulative sentences for offences;
- (f) to require sentences for assaults by prisoners to be served at the expiration of the sentence being undergone at the time of the assault, unless the Court otherwise directs;
- (g) to increase the penalty for an assault by a prisoner on prison officers and other officers;







(2) Whosoever without lawful excuse takes or exercises control, whether direct or through another person, of an aircraft shall be deemed to be guilty of larceny and be liable to penal servitude for seven years.

(3) Whosoever without lawful excuse takes or exercises control, whether direct or through another person, of an aircraft while another person, not being an accomplice of the first-mentioned person, is on board the aircraft shall be deemed to be guilty of larceny and be liable to penal servitude for fourteen years.

(4) Whosoever without lawful excuse, by force or violence or threat of force or violence, or by any trick or false pretence, takes or exercises control, whether direct or through another person, of an aircraft while another person, not being an accomplice of the first-mentioned person, is on board the aircraft shall be deemed to be guilty of larceny and be liable to penal servitude for twenty years.
