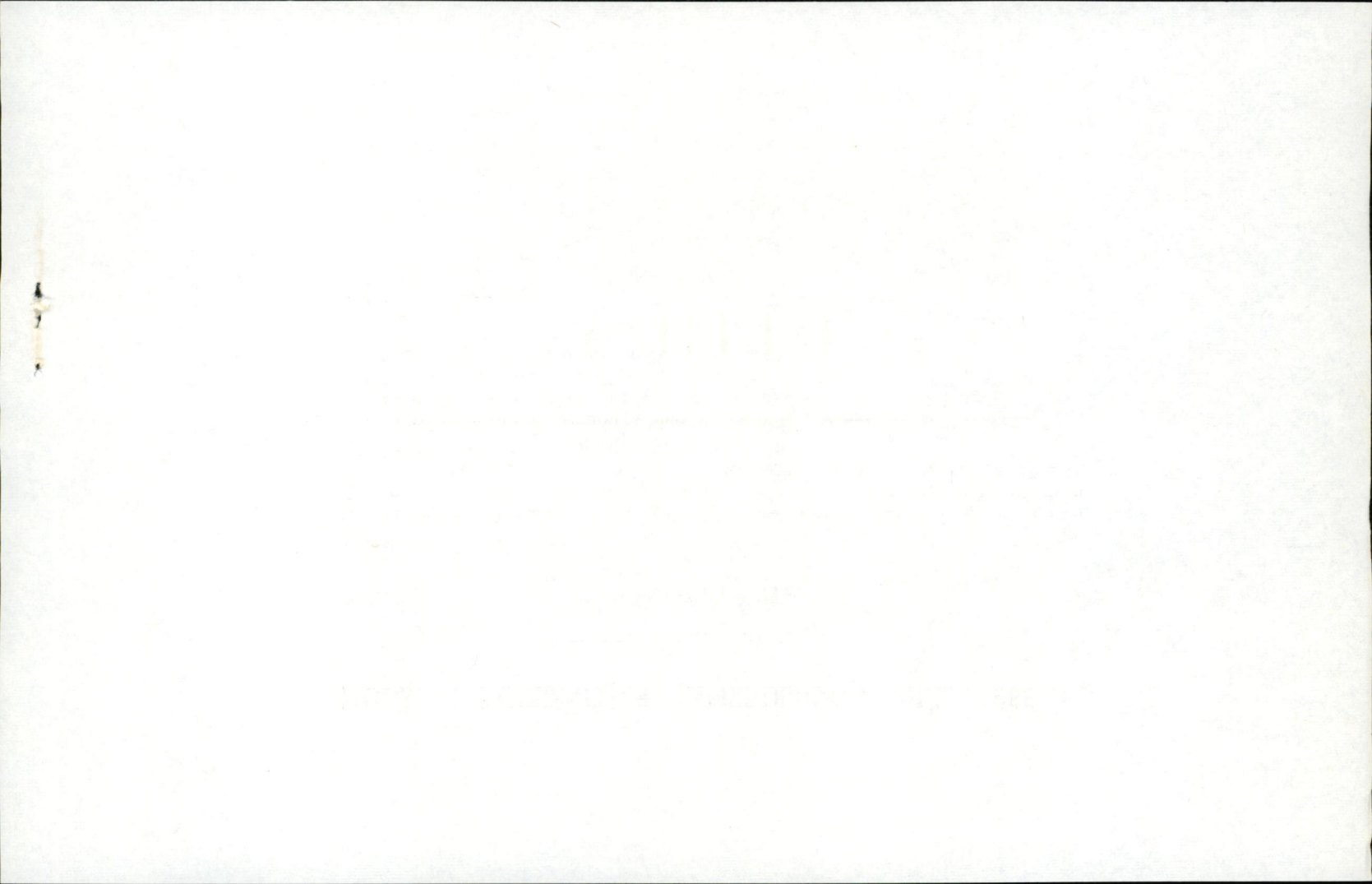
# HOUSING INDEMNITIES (AMENDMENT) BILL, 1965.

## EXPLANATORY NOTE.

THE objects of this Bill are—

- (a) to alter the conditions upon which the Treasurer may indemnify an institution in respect of certain housing loans so that an indemnity may be given where the amount to be lent by the institution does not exceed £4,250, instead of the present amount of £3,750;
- (b) to remove the restriction which at present precludes the Treasurer from executing an indemnity in respect of a loan to purchase a dwelling-house over five years old ;
- (c) to make provisions of an ancillary character.
