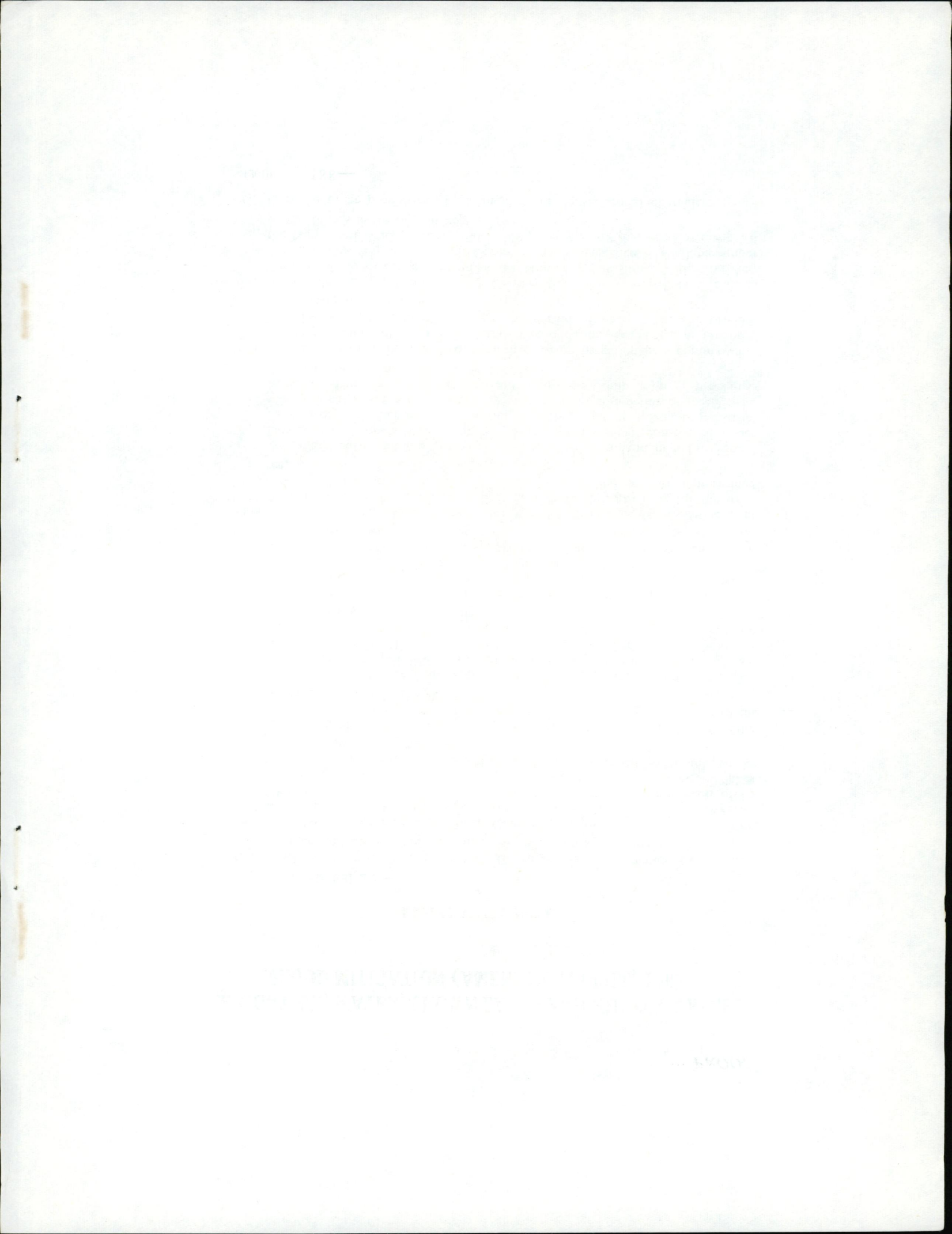

**EXPLANATORY NOTE.**

THE objects of this Bill are—

- (a) to widen the powers of The Water Conservation and Irrigation Commission to enter land for investigations in connection with sub-surface water;
- (b) to make it clear that The Water Conservation and Irrigation Commission is not under any liability to pay compensation or damages under any Act for any loss or damage arising from the exercise by the Commission of its right to the use and flow and to the control of the water in rivers and lakes whether or not that water is impounded in or released from any works controlled by the Commission;
- (c) to vest in The Water Conservation and Irrigation Commission for the benefit of the Crown the right to the use and flow and to the control of all sub-surface water in the State;
- (d) to enable The Water Conservation and Irrigation Commission to revoke, suspend or modify a license or authority for a joint water supply scheme issued under Part II of the Water Act, 1912, as amended by subsequent Acts, if the licensee or holder of the authority uses the work for any purpose other than that expressly authorised by his license or authority;

- (f) to amend the provisions of the Water Act, 1912, as amended by subsequent Acts, relating to the licensing of drillers of bores by providing for the issue of drillers' licenses for a period of three years on payment of a prescribed fee;
- (g) to make it clear that the obligation of a subdivider of land in a Provisional Domestic and Stock Water Supply and Irrigation District constituted under Part VI of the Water Act, 1912, as amended by subsequent Acts, to construct subdivisional works is not affected by notification of completion of the District works by The Water Conservation and Irrigation Commission or proclamation of the final constitution of the District;
- (h) to enable lands to be added to a purchase in an irrigation area coming within the provisions of the Crown Lands Consolidation Act, 1913, as amended by subsequent Acts, in cases where the period of payment of the original purchase money has expired;
- (i) to provide that the Hunter Valley Conservation Trust's contribution towards the cost of works carried out under the Hunter Valley Flood Mitigation Act, 1956, and in respect of which Commonwealth assistance is available under the New South Wales Grant (Flood Mitigation) Act 1964, remains one-third of the State's share of that cost;

- (ii) to take such measures or precautions as may be specified in the notice for the protection of the quality and prevention of pollution or contamination of any sub-surface water wherever pollution or contamination, in the opinion of the Commission, is or may be caused by abandoned, defective or improperly constructed bores through the interconnection of strata or the introduction of unsuitable surface water into the sub-surface water;
- (iii) to furnish to the Commission at such intervals as may be specified in the notice a report of static water level in the bore from a point

point of measurement predetermined by the Commission and of the quantities of water pumped from the bore;

- (iv) to provide, fit and maintain a metering or measuring device acceptable to the Commission which will adequately and continuously record the quantity of water flowing or pumped from a bore from which water is used for any industrial or manufacturing purpose whatsoever or for irrigation,

and may, in any such notice, set forth such requirements as it deems necessary for proper compliance with a direction contained therein;

- (b) the Commission may by notice in writing to the licensee of any bore referred to in paragraph (a) of this subsection—

- (i) specify the minimum distance or distances at which any bore may be sunk from any other bore or bores wheresoever situate;

- (ii) direct the licensee of any bore the sinking of which is completed after the proclamation of the restricted sub-surface water area and from which water is to be used for other than stock, domestic or home garden purposes to furnish to the Commission within ninety days of completion of equipping the bore such detailed particulars of the equipment installed, including the capacity of any pump, as the Commission may require.
