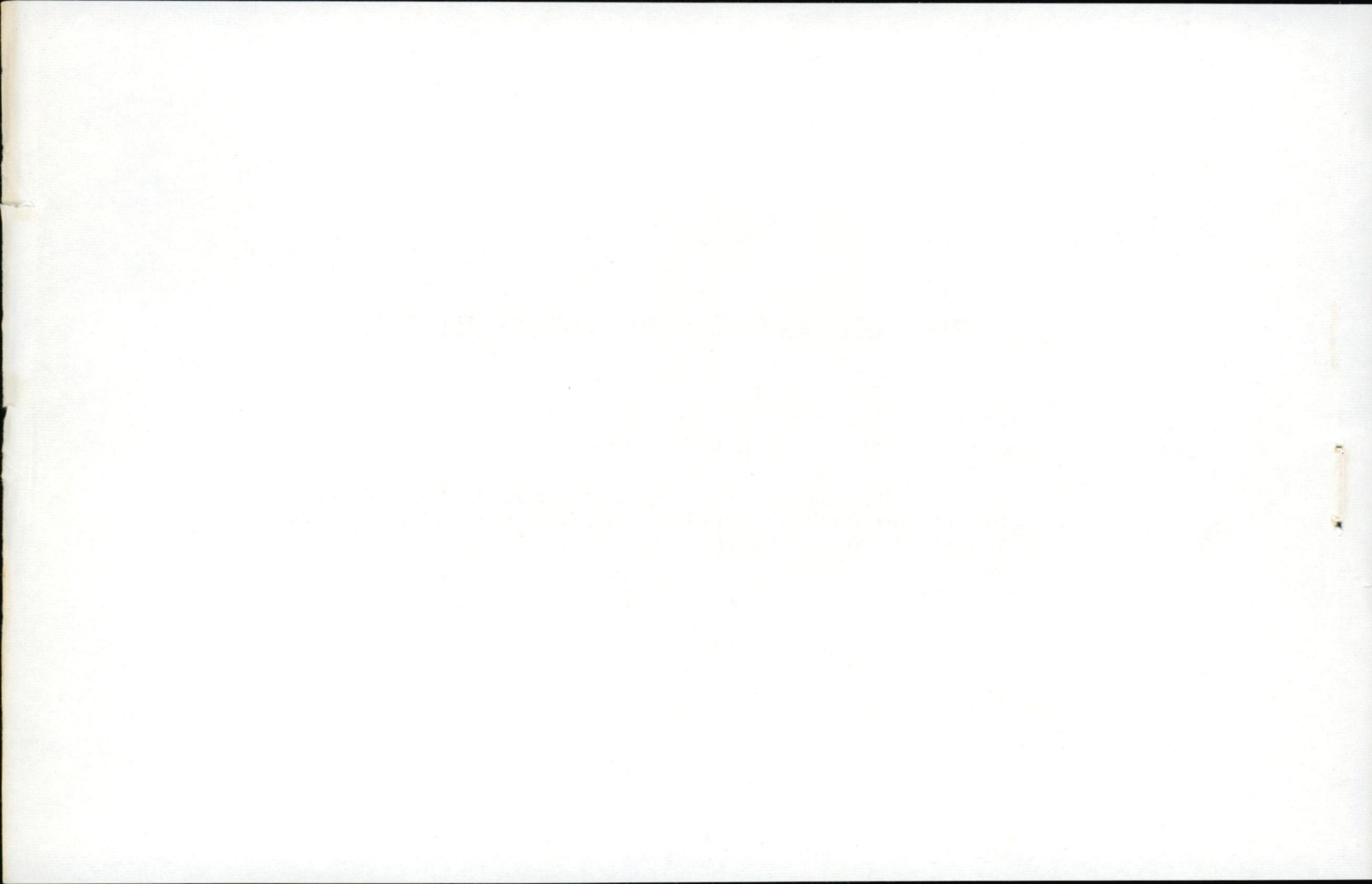

EXPLANATORY NOTE

THE object of this Bill is to amend the Sydney Opera House Act to provide for an increase in the payment from the Opera House Account to the Consolidated Revenue Fund from \$400,000 to \$500,000 per annum.
