
#### **EXPLANATORY NOTE**

THE object of this Bill is to constitute a Council of Law Reporting with eleven members.

The Council is to be empowered—

- (a) to prepare, publish and sell, or arrange for the preparation, publication and sale of law reports, digests of law reports, and legal works relating to such reports;
- (b) to purchase the business of any person engaged in the preparation, publication and sale of law reports and the like;
- (c) to perform other acts and things incidental to or supplemental to the foregoing.

The Council in the exercise and discharge of its powers, authorities, duties and functions, will be required to comply with any directions of the Minister.


