An Act to make further provisions in respect of the employment and safety of persons in factories, the fees payable for the registration of factories and shops, the sale of goods from automatic vending devices, and the early closing of shops; to abolish tobacco licenses; for these and other purposes to amend the Factories, Shops and Industries Act, 1962; and for purposes connected therewith.

### **EXPLANATORY NOTE**

- (g) to amend certain provisions relating to the employment of women and young persons;
- (h) to make provisions consequential upon or ancillary to the foregoing.



# FACTORIES, SHOPS AND INDUSTRIES (AMENDMENT) BILL 1960.

## EXPLANATORY NOTE

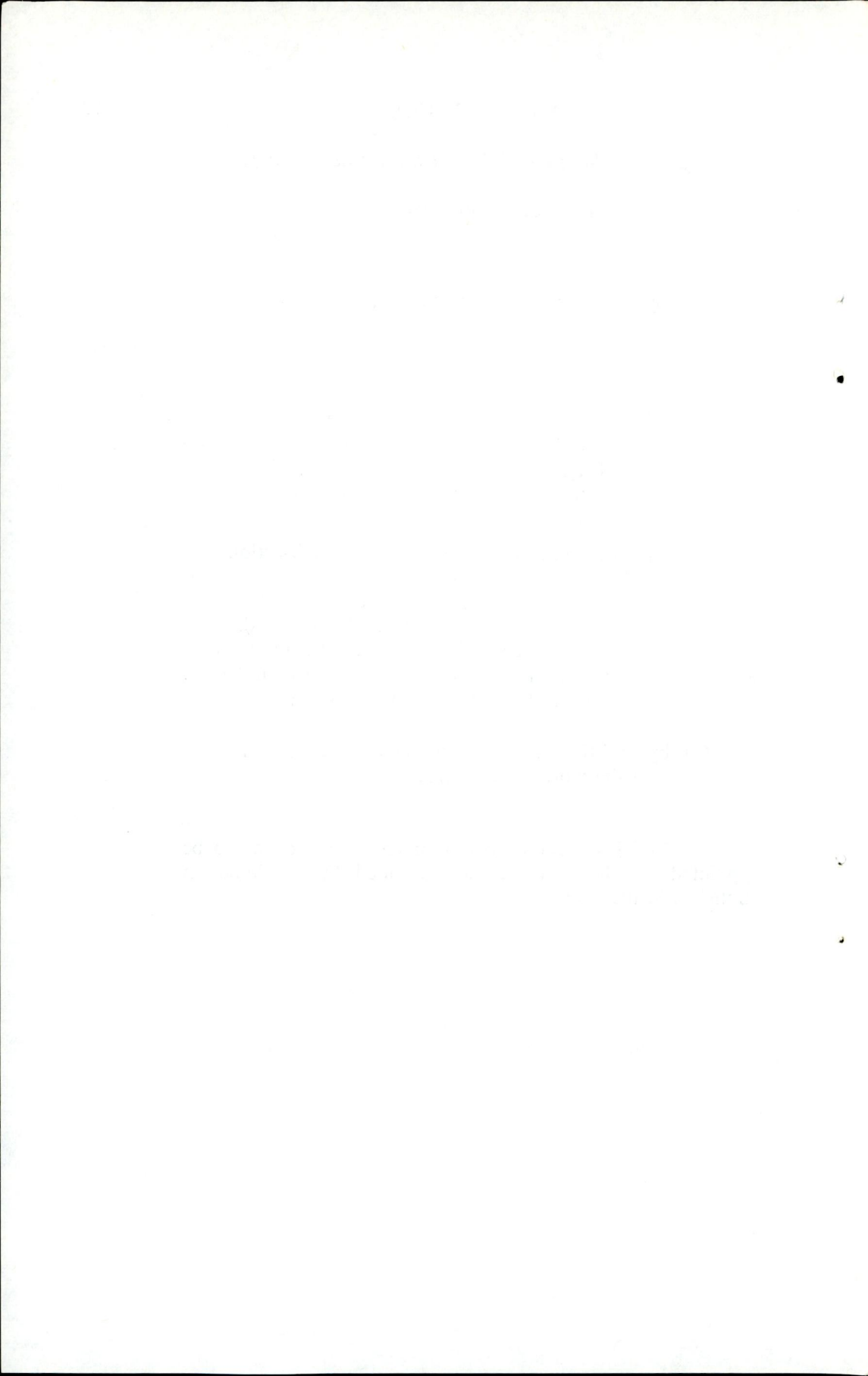
