

Preamble.

HEREAS the Australian Loan Council at its ninety-sixth meeting held on the twenty-sixth day of June, one thousand nine hundred and sixty-nine, decided in pursuance of Clause 3 (9) of Part I of the Agreement set out in the schedule to the Financial Agreement Act, 1944, that the amount to be borrowed for the loan programmes of the Commonwealth and the States for housing and State works for the financial year ending on the thirtieth day of June, one thousand nine hundred and seventy, shall be seven hundred and fifty-eight million dollars, and by unanimous decision allocated an amount of one hundred and ninety-four million five hundred and ninety thousand dollars to the State of New South Wales, BE it enacted therefore by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:—
