HIRE-PURCHASE (AMENDMENT) BILL, 1970

EXPLANATORY NOTE

THE object of this Bill is to provide that without affecting any other grounds upon which an owner of goods may reasonably refuse to enter into a hire-purchase agreement the owner may so refuse unless the insurance of those goods is effected with an approved insurer.

An approved insurer is—

- (a) an insurer licensed under the Workers' Compensation Act, 1926; or
- (b) a person who is an authorised insurer under the Motor Vehicles (Third Party) Insurance Act, 1942.
