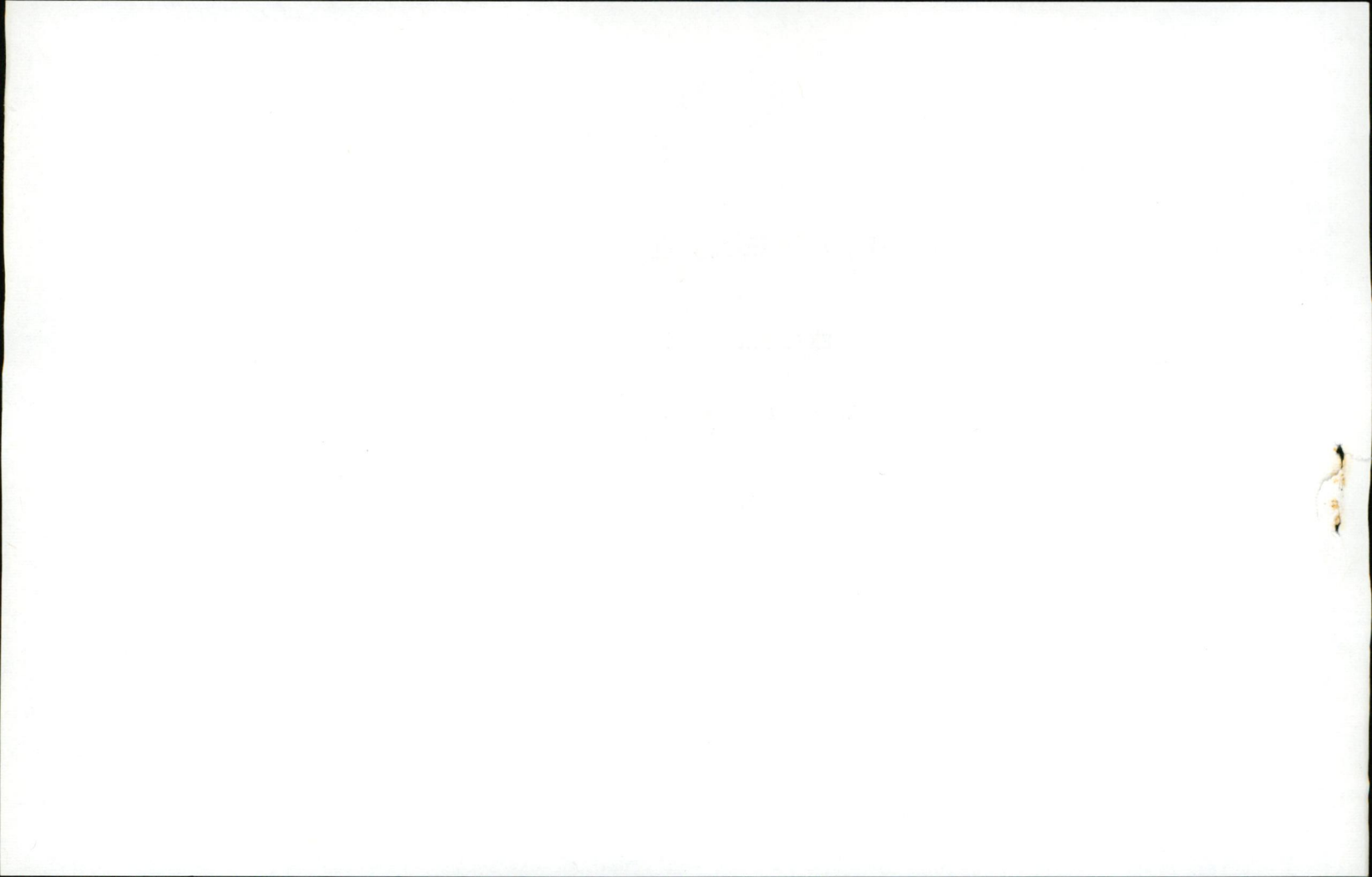

LIBRARY (AMENDMENT) BILL, 1969

EXPLANATORY NOTE

THE object of this Bill is to increase the maximum subsidy payable by the State to the council of an area in respect of the library services provided by the council under the Library Act, 1939, from thirty cents for each person resident within the area to forty-five cents for each person so resident.
