
## MORATORIUM (AMENDMENT) BILL, 1968.

#### **EXPLANATORY NOTE.**

As a condition precedent to the making of a loan to be secured by a mortgage of land, it has been, and is, the practice of mortgagees to require a mortgagor to take advantage of the machinery provided by the 1932 Act to "contract out" of the Moratorium Acts.

In view of that practice, the object of this Bill is to avoid the inconvenience and expense to which mortgagors are subjected in complying with such a requirement.


