4. The proceeds of sale after payment of all costs expenses Application and encumbrances shall be held by the Trustees for the time of sale. being of the Peak Hill A.I.F. Memorial School of Arts for the general purposes of the Trust and shall be invested and applied as the Minister administering the Public Instruction Act of 1880 or any Act in substitution of the same may from time to time direct.
