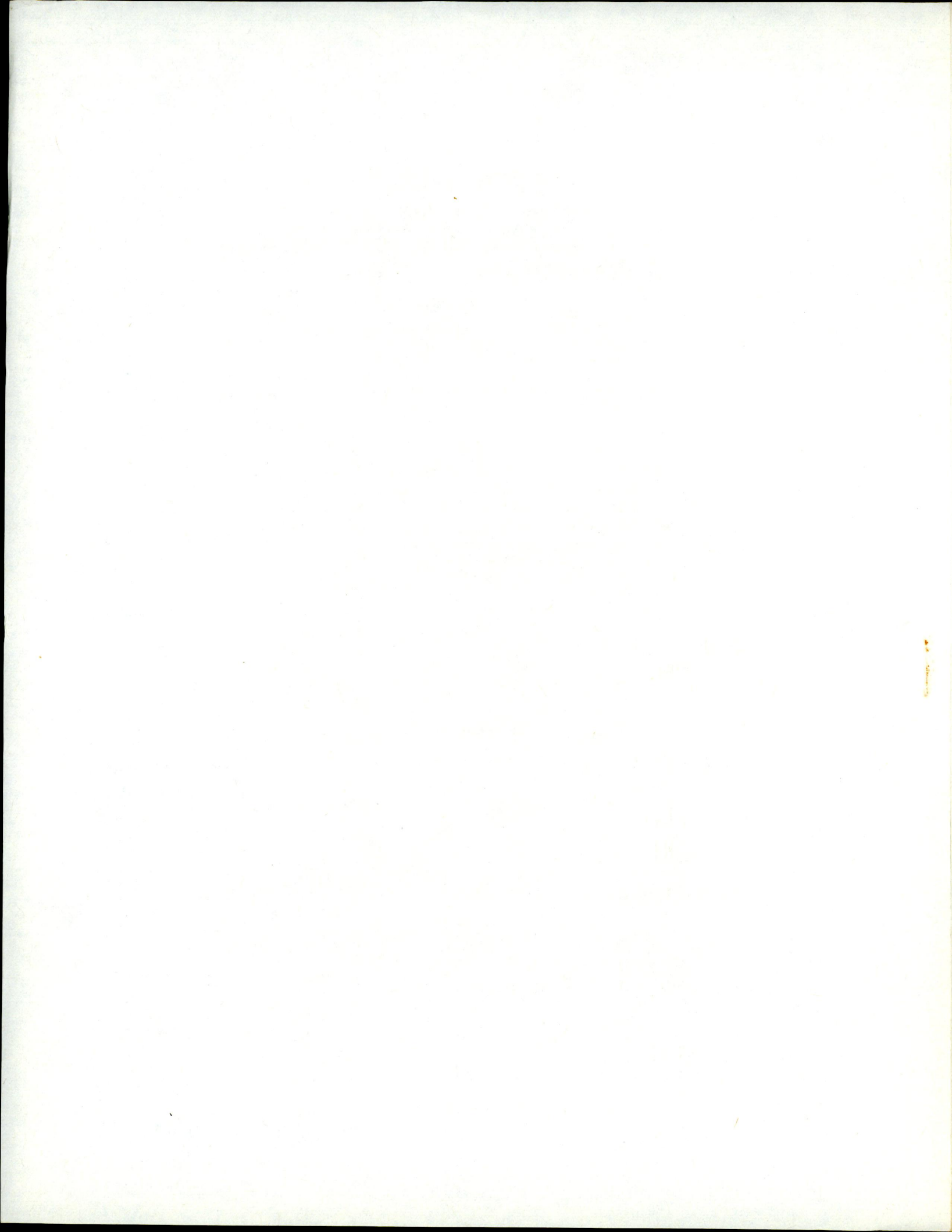

EXPLANATORY NOTE

THE objects of this Bill are—

- (a) to divest The Maritime Services Board of New South Wales of certain reclaimed land adjacent to the Taronga Zoological Park and to vest such land in Her Majesty;
- (b) to add such reclaimed land to the Taronga Zoological Park; and
- (c) to validate the acts of the Trustees of Taronga Zoological Park done in relation to such reclaimed land before the enactment of this legislation.
