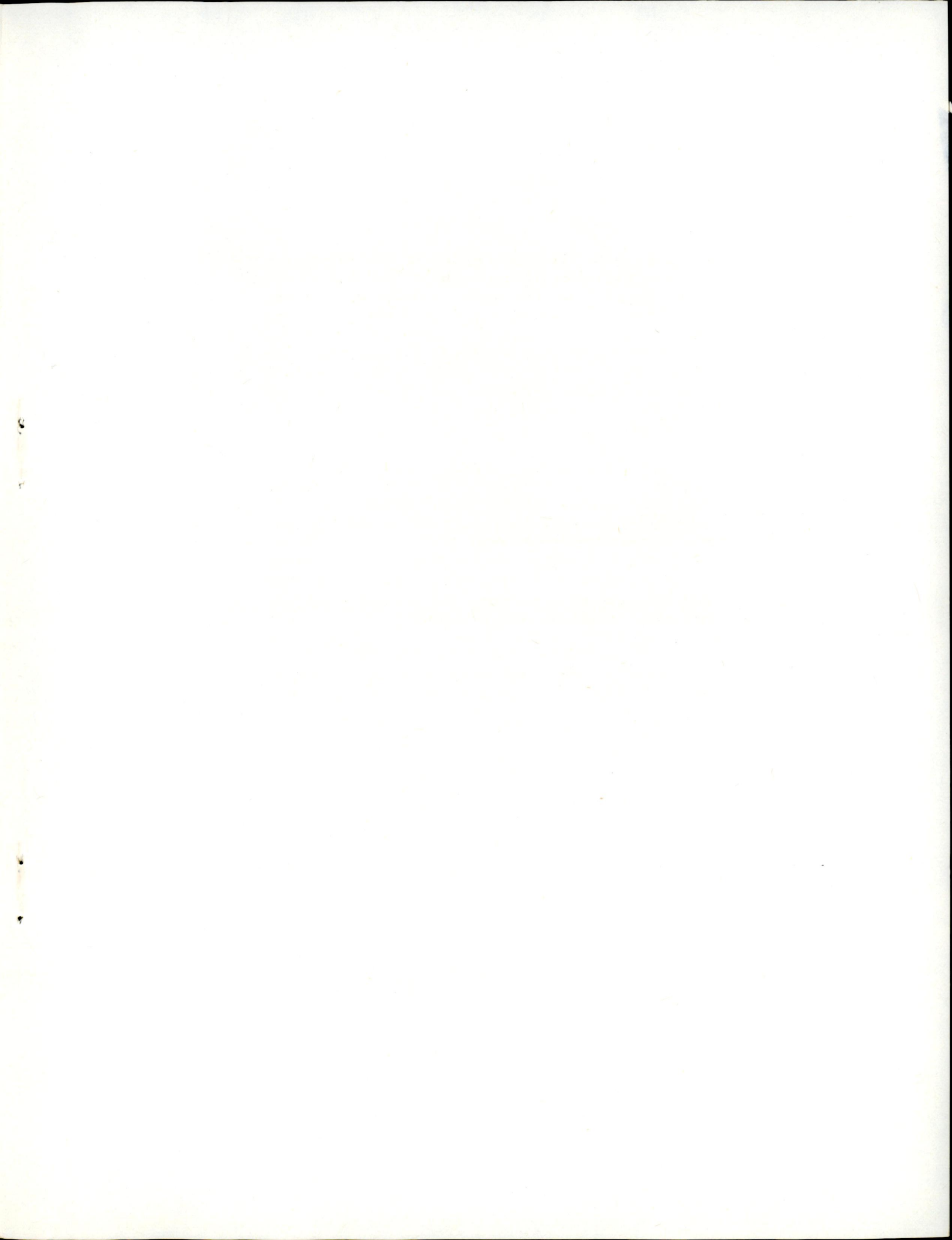

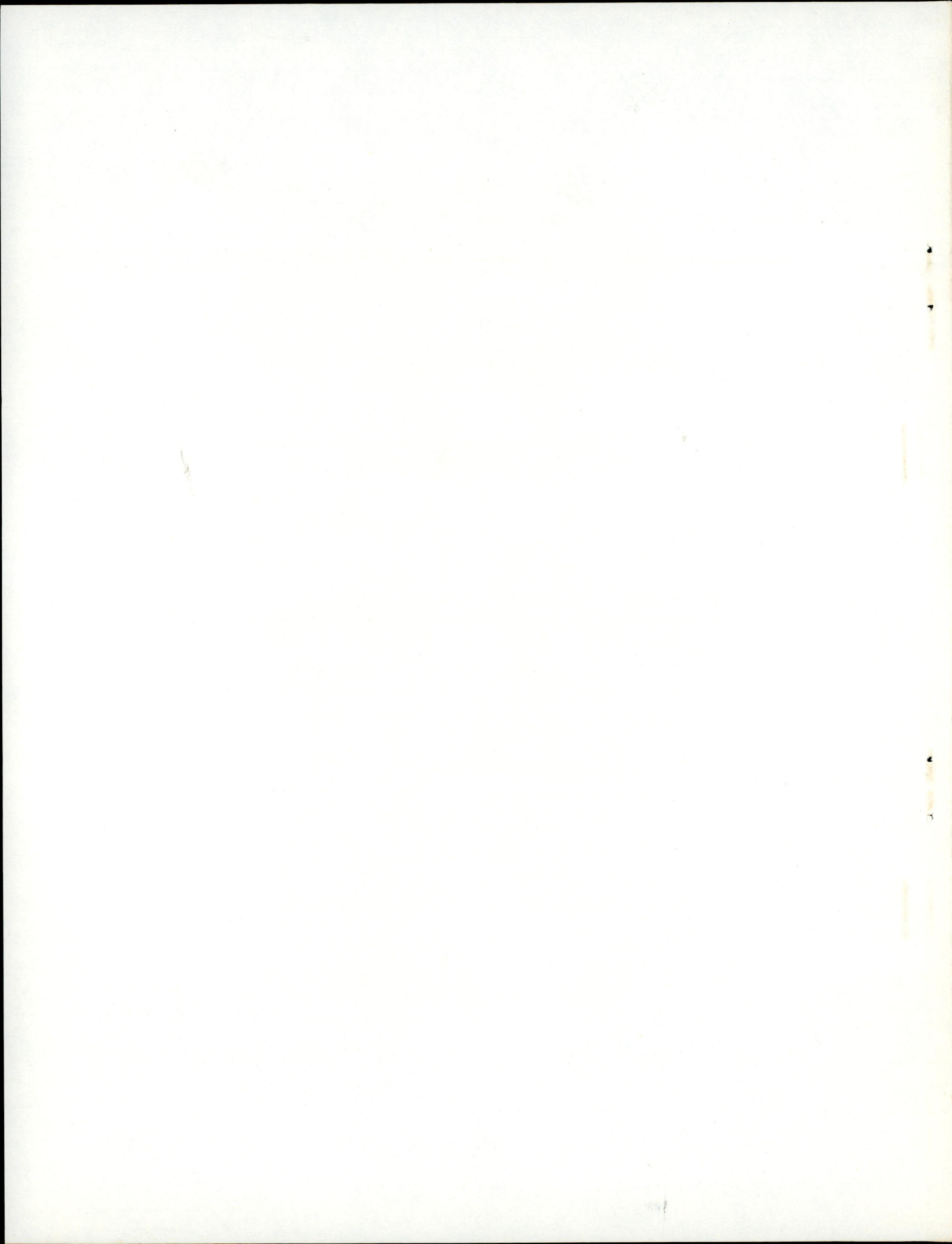

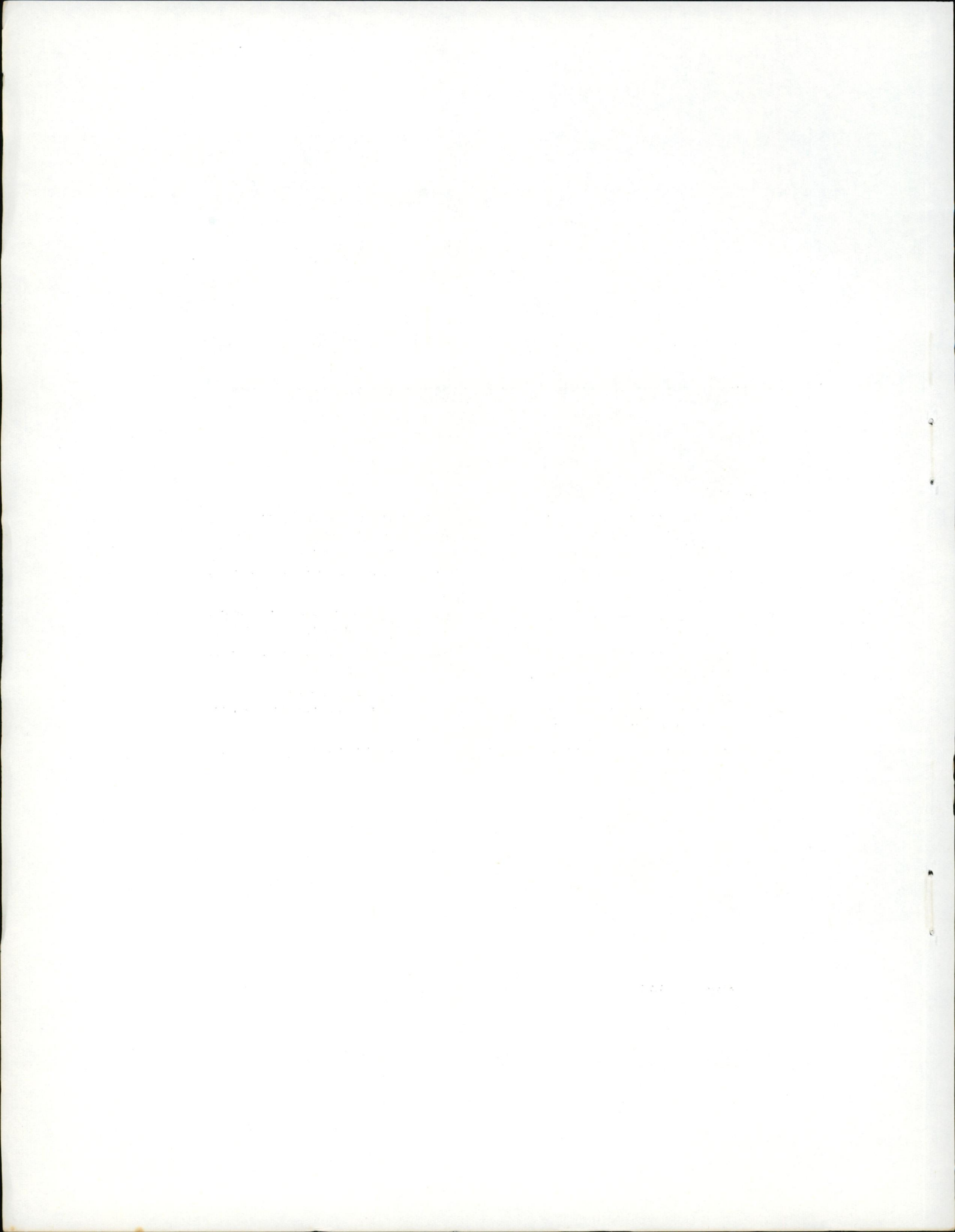

UNIVERSITY OF NEWCASTLE (AMENDMENT) BILL, 1970

EXPLANATORY NOTE

THE objects of this Bill are—

- (a) to provide that the members of the Council of The University of Newcastle elected by each House of Parliament are to be so elected as soon as practicable after each triennial or general election, as the case may be;
- (b) to increase the number of members of the Council elected by the students from one to two;
- (c) to permit a person under the age of twenty-one years to be a member of the Council, or of Convocation, if he is otherwise qualified to be a member;
- (d) to provide that the Chancellor need not be elected from among the members of the Council;
- (e) to enable the Council to make by-laws to empower any authority or officer of the University to make regulations, rules or orders not inconsistent with the Act or by-laws; and
- (f) to make other provisions of a minor or consequential character.

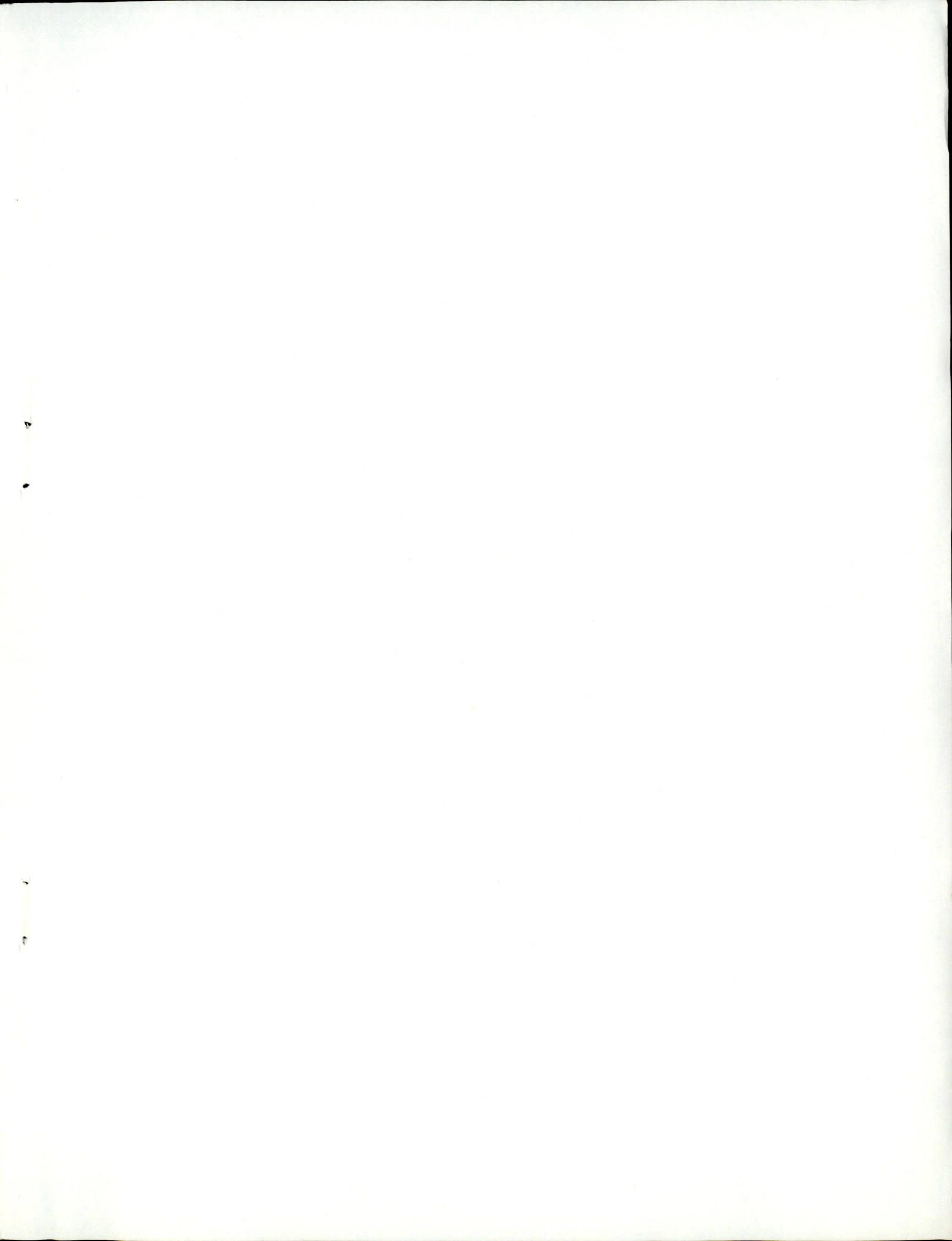

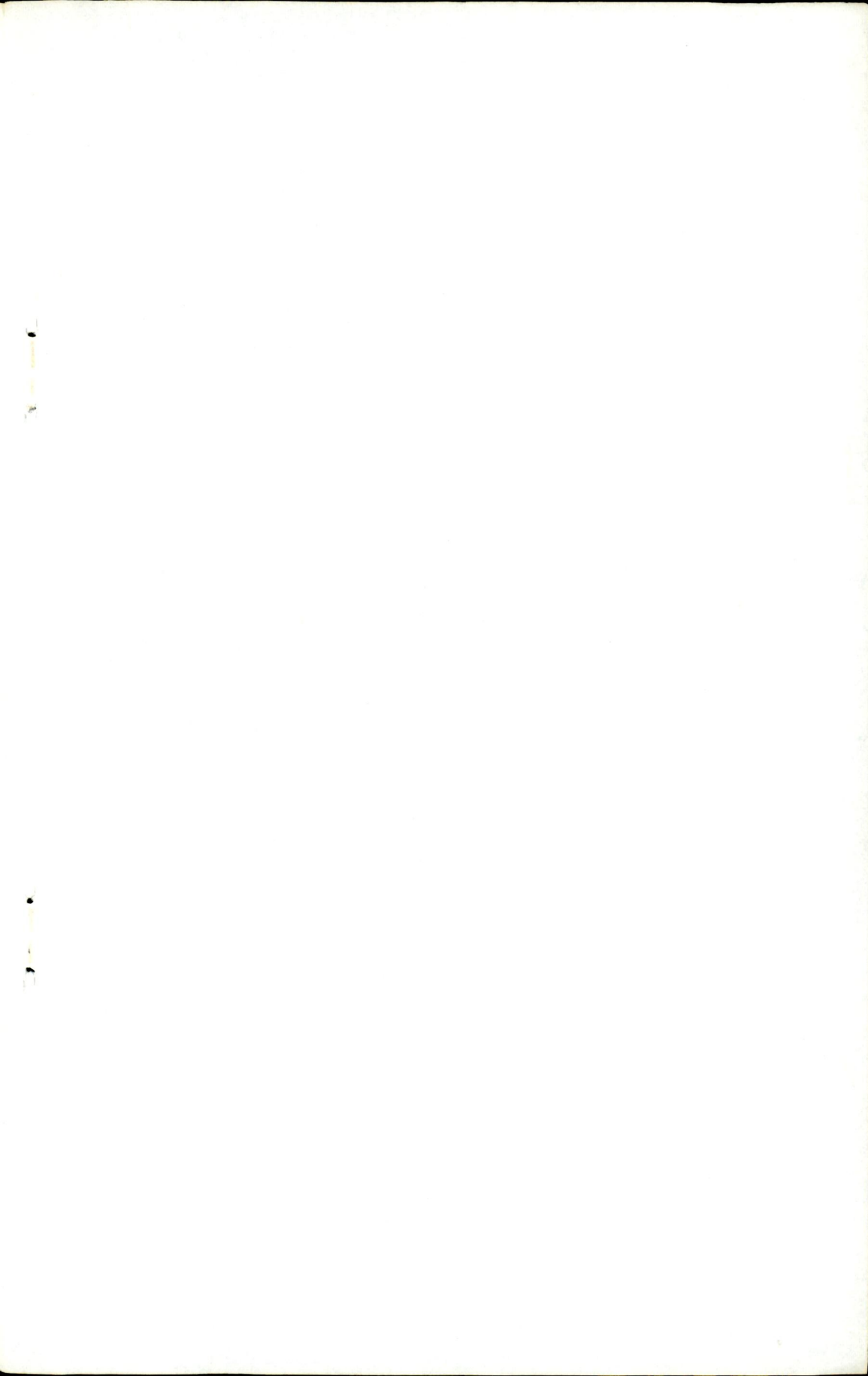

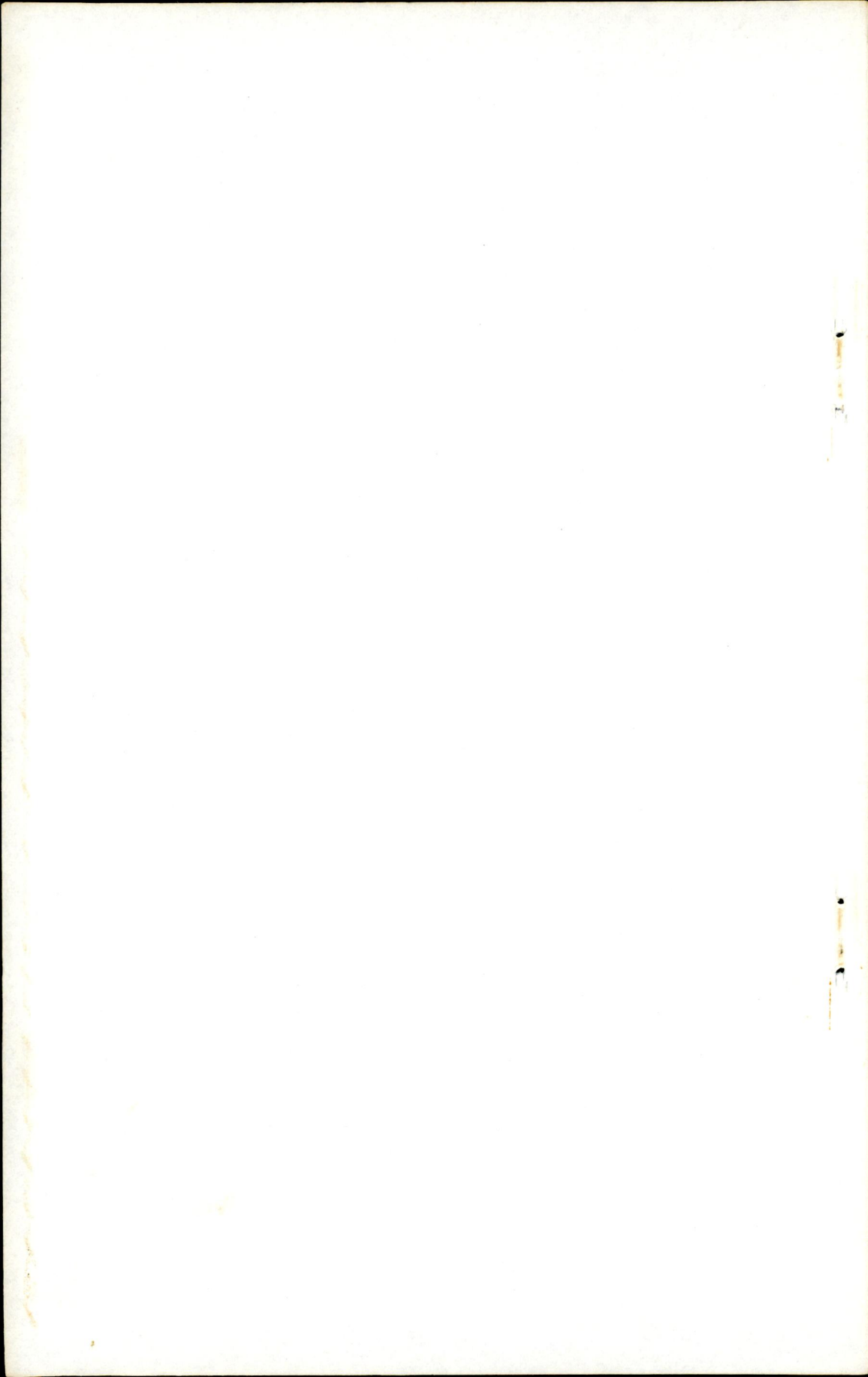

University of Newcastle (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the "University of Newcastle (Amendment) Act, 1970".

(2) This Act shall commence upon a day to be appointed by the Governor and notified by proclamation published in the Gazette.

(3) The University of Newcastle Act, 1964, is, in this Act, referred to as the Principal Act.

- (2) Nothing in this section shall prejudice or affect the continuity of the body corporate constituted under section four of the Principal Act, but the same shall continue notwithstanding the provisions of this section.
- (3) Nothing in this section shall affect the tenure of office of the person holding the office of Chancellor immediately before the commencement of this Act.

(4) Notwithstanding anything in this section, the member elected under subsection three or four of section ten of the Principal Act and holding office as such member immediately before the commencement of this Act shall be deemed to have been elected under subsection three or four of section ten of that Act, as amended by this section, as the case may require, and he shall, subject to sections eleven and twelve of that Act, as so amended, hold office until a member of the House of Parliament which elected him is elected by that House to replace him.

(5) Notwithstanding anything in this section, the member elected under subsection six of section ten of the Principal Act and holding office as such member immediately before the commencement of this Act shall be deemed to have been elected under subsection six of section ten of that Act, as amended by this section, and he shall, subject to sections eleven and twelve of that Act, as so amended, hold office until the expiration of the period for which he would have held office had this Act not been enacted.

(6) Any member of the Council referred to in subsection four or five of this section shall, subject to the Principal Act, as amended by this section, be eligible for re-election.
