



# **GOVERNMENT GUARANTEES (AMENDMENT) BILL, 1972**

### EXPLANATORY NOTE

THE objects of this Bill are-

- (a) to make provision for the execution, for and on behalf of the Treasurer by any other Minister of the Crown whom the Treasurer may authorise in writing for the purpose, of any guarantee authorised to be given under the Government Guarantees Act, 1934, for the repayment of any advance made to a building society that is a terminating building society within the meaning of the Co-operation Act, 1923;
- (b) to make other provisions of a minor or ancillary nature.
