

HIGHER EDUCATION (AMENDMENT) BILL, 1971

EXPLANATORY NOTE

THE objects of this Bill are-

- (a) to enable the membership of the Advanced Education Board to be increased from nine to eleven members;
- (b) to redefine the powers and duties of the Advanced Education Board, particularly with respect to colleges of advanced education forming part of Government Departments not administered by the Minister administering the Higher Education Act, 1969;
- (c) to require that elected members of corporate colleges of advanced education shall have prescribed qualifications or experience;
- (d) to enable land held by the Crown or the Minister on which a corporate college of advanced education conducts its activities to be transferred to that college;
- (e) to require the Minister's consent to a disposition of land by a corporate college of advanced education;
- (f) to confer on corporate colleges of advanced education a power of delegation;
- (g) to extend the powers of corporate colleges of advanced education in relation to the making of by-laws;
- (h) to exempt from rates under the Local Government Act, 1919, the Metropolitan Water, Sewerage, and Drainage Act, 1924, and the Hunter District Water, Sewerage and Drainage Act, 1938, lands vested in corporate colleges of advanced education and used or occupied solely for that purpose;
- (i) to make other amendments of a minor or ancillary nature.




