5. (1) The Governor shall, in the instrument of appoint- Chairman ment of the members of the Institute, as first constituted, and Deputy appoint one of the members as Chairman of the Institute.

(2) The member appointed as Chairman under sub-15 section (1) shall, subject to this Act, hold office as Chairman for a term of two years.

(3) If the member appointed as Chairman under subsection (1), or a person appointed as Chairman under this subsection, ceases to be the Chairman, the Governor shall, by20 instrument in writing, appoint another member to be Chairman for the remainder of his predecessor's term of office.

(4) On the expiration of the term of office of a Chairman appointed under subsection (1) or (3), the members shall from time to time elect one of their number to be 25 Chairman.

  - (d) he becomes a temporary patient or a continued treatment patient, a protected person or an incapable person within the meaning of the Mental Health Act, 1958, or a person under detention under Part VII of that Act;
  - (e) he is convicted in New South Wales of a felony or of a misdemeanour punishable by imprisonment for twelve months or longer, or if he is convicted elsewhere than in New South Wales of an offence which if committed in New South Wales would be a felony or a misdemeanour so punishable;
- (f) he resigns his office by writing under his hand addressed to the Governor;
  - (g) being a member referred to in section 4 (3) (a)
    (iii) or (iv), he ceases to hold the qualification by virtue of which he was appointed;
- 30 (h) he attains the age of sixty-five years; or
  - (i) he is removed from office by the Governor.

(2) The Governor may, for any cause which appears to him sufficient, remove a member from office.




