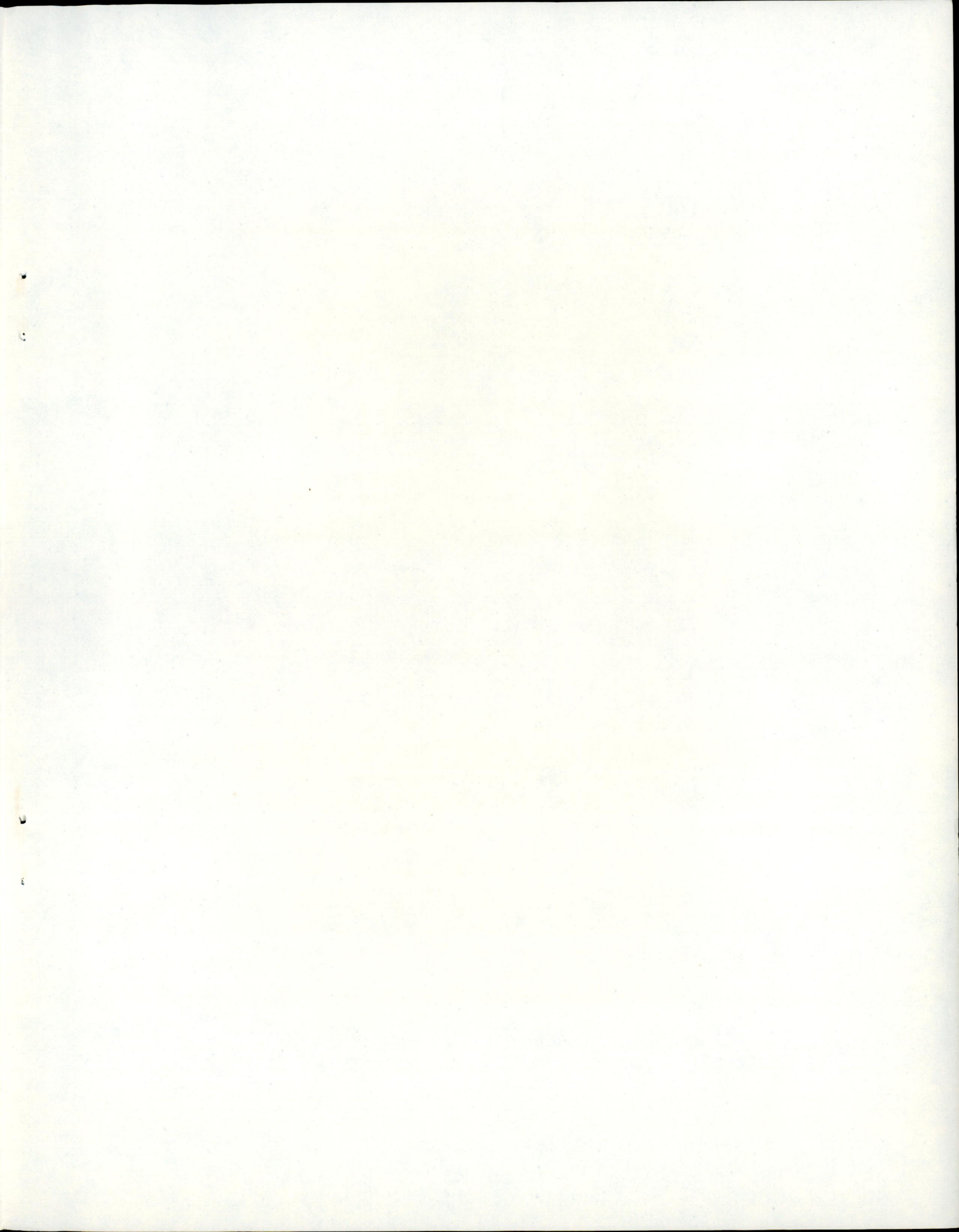

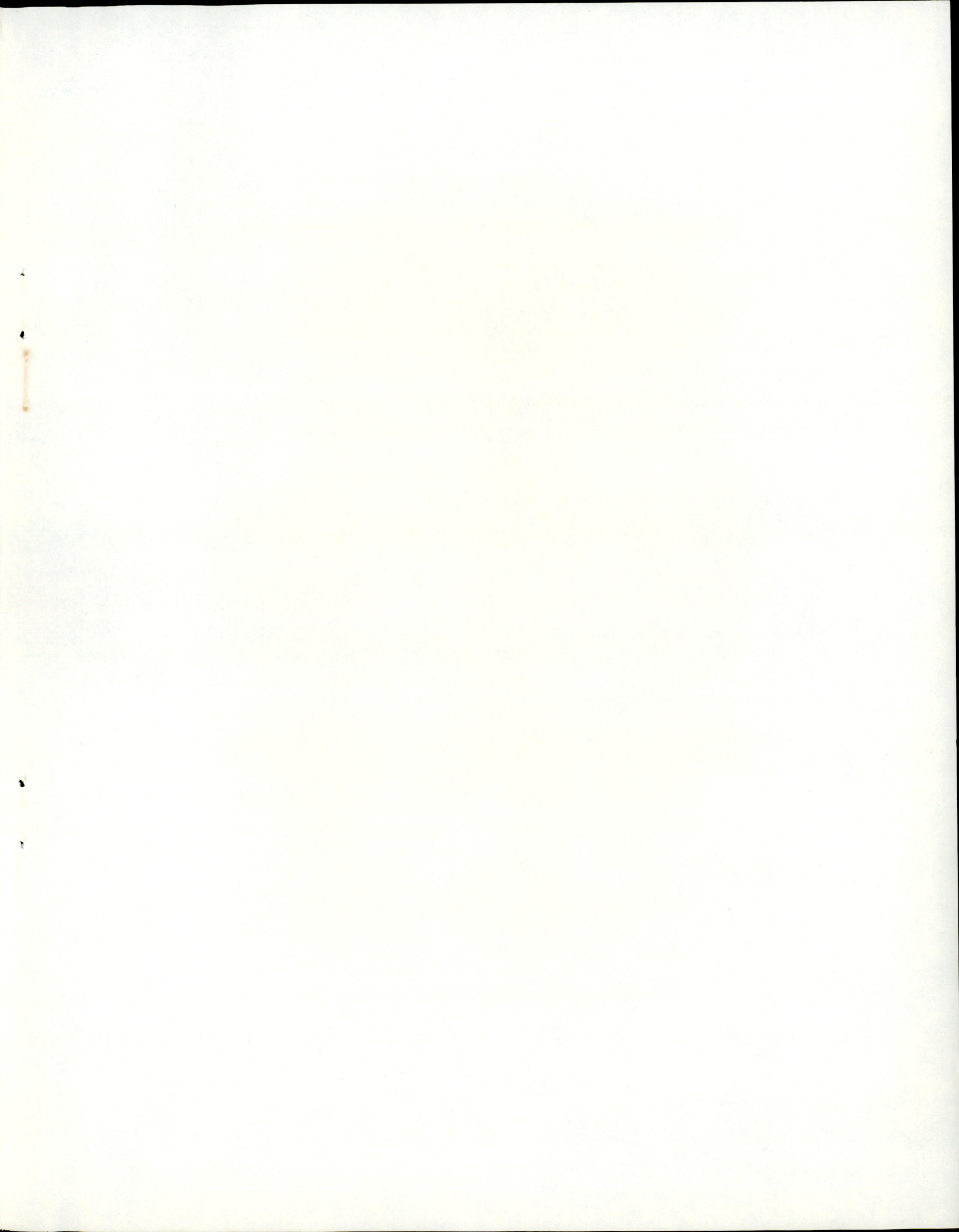

EXPLANATORY NOTE

THE objects of this Bill are—

- (a) to constitute a Newcastle Fruit and Vegetable Marketing District;
- (b) to provide that where the Council of the City of Newcastle provides a market for the sale by wholesale of certain fruit and vegetables within its area, no other wholesale market shall be provided within the Newcastle marketing district for twenty-five years;
- (c) to give a ten year franchise, subject to certain conditions, to wholesalers who transfer their activities from the existing market to a market provided by the Council of the City of Newcastle;
- (d) to apply the provisions of the Local Government Act, 1919, to a market provided by the Council of the City of Newcastle; and
- (e) to make other provisions of a consequential or ancillary character.
