

PHYSIOTHERAPISTS REGISTRATION (AMENDMENT) BILL, 1971

EXPLANATORY NOTE

THE objects of this Bill are-

- (a) to extend the powers of inspectors to enter premises to include power to enter premises in which it is reasonably suspected that the provisions of the Physiotherapists Registration Act, 1945, or the regulations made thereunder are being contravened;
