An Act to provide for the appointment of a Deputy Commissioner of Police and Assistant Commissioners of Police; to make certain provisions in respect of other matters affecting the police force; for these purposes to amend the Police Regulation Act, 1899, and the Police Regulation (Superannuation) Act, 1906; and for purposes connected therewith.

**B**E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the "Police Regulation (Amendment) Act, 1971". Short title and commencement.

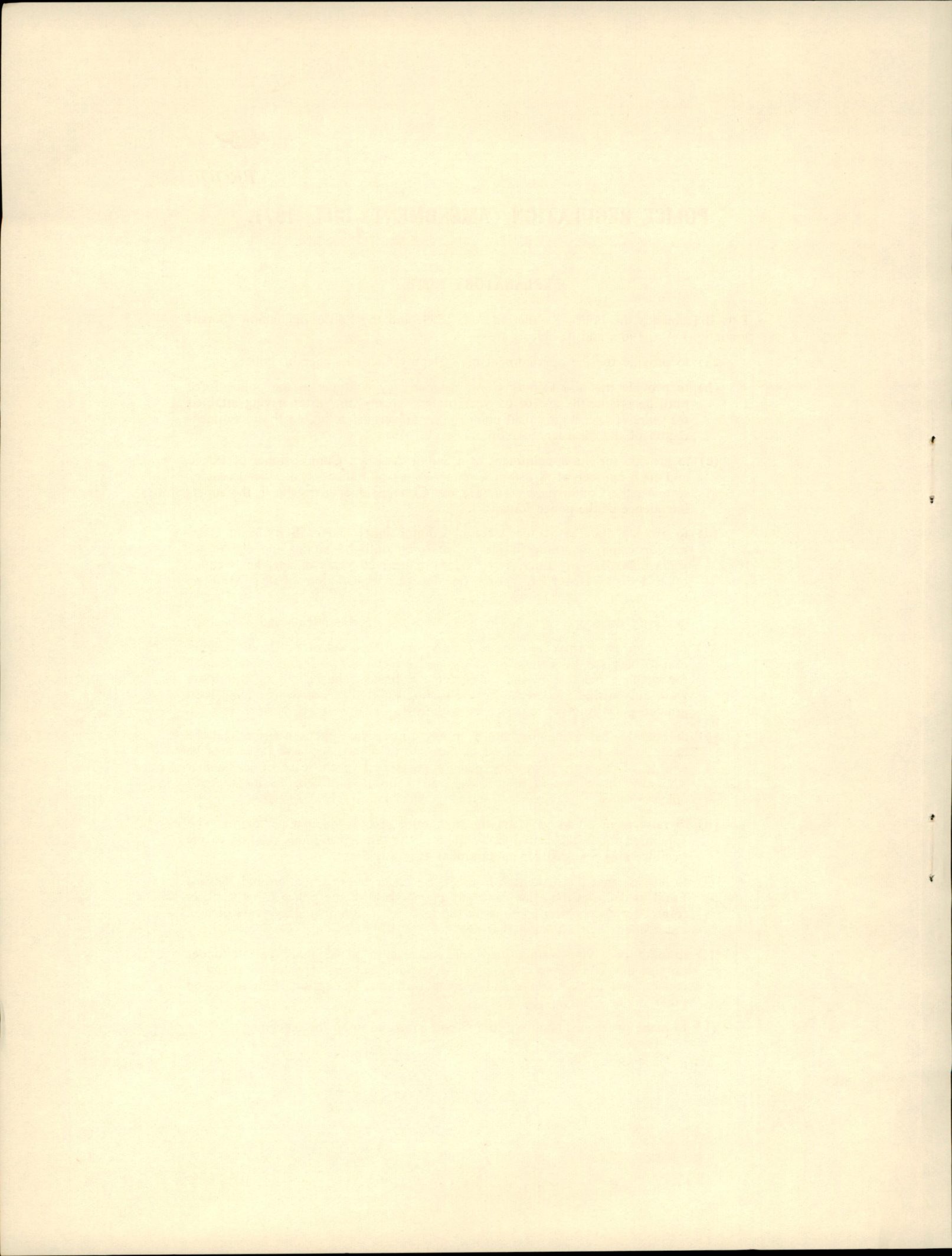
**POLICE REGULATION (AMENDMENT) BILL, 1971.**

---

**EXPLANATORY NOTE.**

THIS Bill amends the Police Regulation Act, 1899, and the Police Regulation (Superannuation) Act, 1906, and its objects are—

- (a) to provide for the appointment of a Deputy Commissioner of Police;
- (b) to provide that the Deputy Commissioner may continue in the police force until he attains the age of 65 years unless, at any time after having attained 60 years of age, he is called upon by the Governor, acting on the recommendation of the Minister, to retire;
- (c) to provide for the appointment of a Senior Assistant Commissioner of Police and such number of Assistant Commissioners of Police as may be necessary to assist the Commissioner and Deputy Commissioner generally in the superintendence of the police force;
- (d) to provide that the Senior Assistant Commissioner and each Assistant Commissioner may continue in the police force until he attains the age of 62 years unless, at any time after having attained 60 years of age, he is called upon by the Governor, acting on the recommendation of the Minister, to retire;
- (e) to clarify the scope of authority and duties of superintendents and inspectors;

An Act to provide for the appointment of a Deputy Commissioner of Police and Assistant Commissioners of Police; to make certain provisions in respect of other matters affecting the police force; for these purposes to amend the Police Regulation Act, 1899, and the Police Regulation (Superannuation) Act, 1906; and for purposes connected therewith. **B**E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**1.** (1) This Act may be cited as the "Police Regulation (Amendment) Act, 1971".

(2) This Act shall commence upon a day to be appointed by the Governor and notified by proclamation published in the Gazette.

**2.** The Police Regulation Act, 1899, is amended—

4A. (1) The Governor may from time to time appoint a Deputy Commissioner of Police.

(2) The Deputy Commissioner shall receive such remuneration as the Governor may determine.

(3) The Deputy Commissioner may continue in the police force until the day upon which he attains the age of sixty-five years unless he is sooner retired by the Governor acting upon the recommendation of the Minister or after attaining the age of sixty years he sooner retires.

(4) The Deputy Commissioner shall exercise and perform such of the powers, authorities, duties and functions of the Commissioner as the Commissioner may from time to time direct either generally or in any special case and any power, authority, duty or function so exercised or performed by the Deputy Commissioner shall be as valid and effectual as if exercised or performed by the Commissioner.

(5) (a) During the illness or absence of the Commissioner or whenever the Commissioner though on duty cannot be contacted or whenever there is a vacancy in the office of Commissioner the Deputy Commissioner shall have and may exercise and perform the powers, authorities, duties and functions conferred or imposed on the Commissioner by or under this or any other Act.

(b) No person shall be concerned to enquire whether or not any occasion has arisen requiring or authorising the Deputy Commissioner to act in the place of the Commissioner and all acts and things done or omitted by the Deputy Commissioner while acting as Commissioner shall have the same consequences as if they had been done or omitted by the Commissioner.

4B. (1) The Governor may from time to time appoint a Senior Assistant Commissioner of Police and such number of Assistant Commissioners of Police as he may determine to be necessary.

(2) The Senior Assistant Commissioner and each Assistant Commissioner shall receive such remuneration as the Governor may determine.

(3) The Senior Assistant Commissioner and an Assistant Commissioner may continue in the police force until the day upon which he attains the age of sixty-two years unless he is sooner retired by the Governor acting upon the recommendation of the Minister or after attaining the age of sixty years he sooner retires.

4C. (1) The Senior Assistant Commissioner shall as directed by the Commissioner or Deputy Commissioner either generally or in any special case exercise and perform such of the powers, authorities, duties and functions—

(a) of the Commissioner or Deputy Commissioner to which any such direction relates, or

(b) as may have been delegated by the Commissioner to any Assistant Commissioner in pursuance of subsection two of section 4D of this Act.

(2) Any power, authority, duty or function exercised or performed by the Senior Assistant Commissioner in pursuance of any such direction shall be as valid and effectual as if exercised or performed by the Commissioner or Deputy Commissioner, as the case may be.

(3) (a) During the illness or absence of the Deputy Commissioner or whenever the Deputy Commissioner though on duty cannot be contacted or whenever there is a vacancy in the office of Deputy Commissioner the Senior Assistant Commissioner shall have and may exercise and perform the powers, authorities, duties and functions of the Deputy Commissioner.

(b) During the illness or absence of the Commissioner and Deputy Commissioner or whenever the Commissioner and Deputy Commissioner though on duty cannot be contacted or whenever there is a vacancy in the offices of Commissioner and Deputy Commissioner the Senior Assistant Commissioner shall have and may exercise and perform the powers, authorities, duties and functions of the Commissioner.

(c) The provisions of paragraph (b) of subsection five of section 4A of this Act shall apply, mutatis mutandis, to the Senior Assistant Commissioner acting as Deputy Commissioner or Commissioner pursuant to paragraph (a) or (b) of this subsection.

4D. (1) An Assistant Commissioner shall have Authority and may exercise and perform such powers, of Assistant authorities, duties and functions as may from time Commis- sioners. to time—

(a) be delegated by the Commissioner by instrument in writing to him either generally or in a particular case or class of cases, or

(b) be the subject of a direction by the Commissioner or Deputy Commissioner.

(2) Any power, authority, duty or function exercised or performed by an Assistant Commissioner who is acting within the scope of any such delegation or direction shall be as valid and effectual as if exercised or performed by the Commissioner or Deputy Commissioner, as the case may be.

(3) A delegation or direction under subsection two of this section shall be revocable at the will of the Commissioner or Deputy Commissioner as the case may be and any such delegation or direction shall not prevent the discharge, exercise or performance by the Commissioner or the Deputy Commissioner of any power, authority, duty or function so delegated or the subject of any such direction.

(4) An Assistant Commissioner shall, when discharging, exercising or performing any power, authority, duty or function referred to in subsection one of this section, be presumed, in the absence of evidence to the contrary, to be acting within the scope of any such delegation or direction to him.

- No deduction pursuant to subsection one of this section from the pay and salary of a member of the police force to whom this subsection applies shall be made—
- (a) in the case of any such member who has attained the age of sixty years before the commencement of the Police Regulation (Amendment) Act, 1971, after the fortnightly pay period next after such commencement; or

3. A person who immediately before the commencement of this Act held office as an Assistant Commissioner of Police shall subject to the Police Regulation Act, 1899, continue to hold office as such until he attains the age of sixty years or he is appointed under section 4A or section 4B of the said Act, whichever event first occurs.

4. The Police Regulation (Superannuation) Act, 1906, is amended by inserting at the end of section nine the following proviso :—

Provided that the age of retirement of the Deputy Commissioner of Police, the Senior Assistant Commissioner of Police and an Assistant Commissioner of Police may be as extended by subsection three of section 4A or subsection three of section 4B of the Police Regulation Act, 1899.
