An Act to increase the superannuation allowances payable to certain retired members of the Police Force and certain widows and other persons; for this and other purposes to amend the Police Regulation (Superannuation) Act, 1906, and the Police Association Employees (Superannuation) Act, 1969; and for purposes connected therewith.

*Police Regulation (Superannuation) Amendment.*

**B**E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. This Act may be cited as the "Police Regulation (Superannuation) Amendment Act, 1972". Short title.

2. (1) Subject to subsections (2) and (3), this Act commences on the date of assent thereto. Commencement.

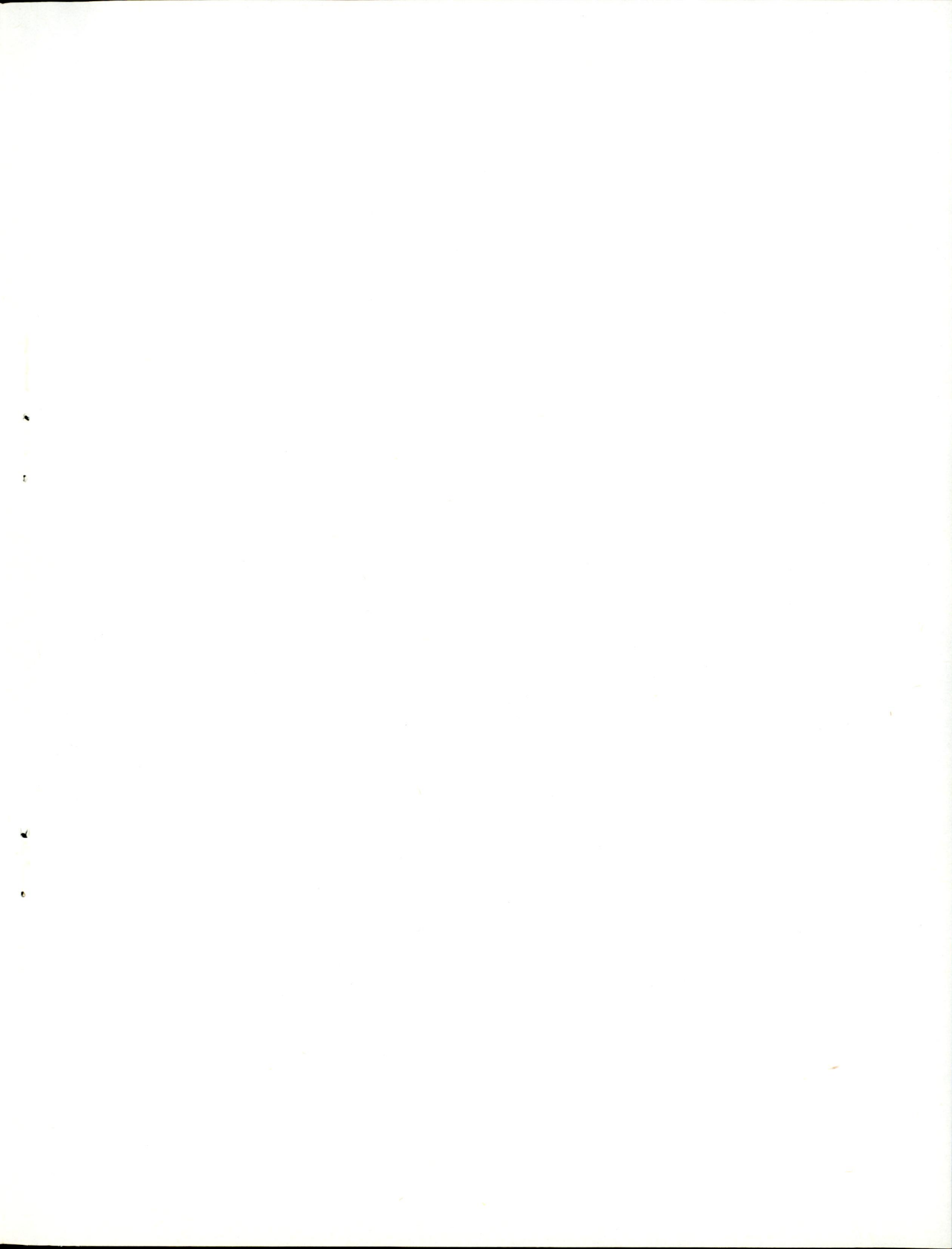

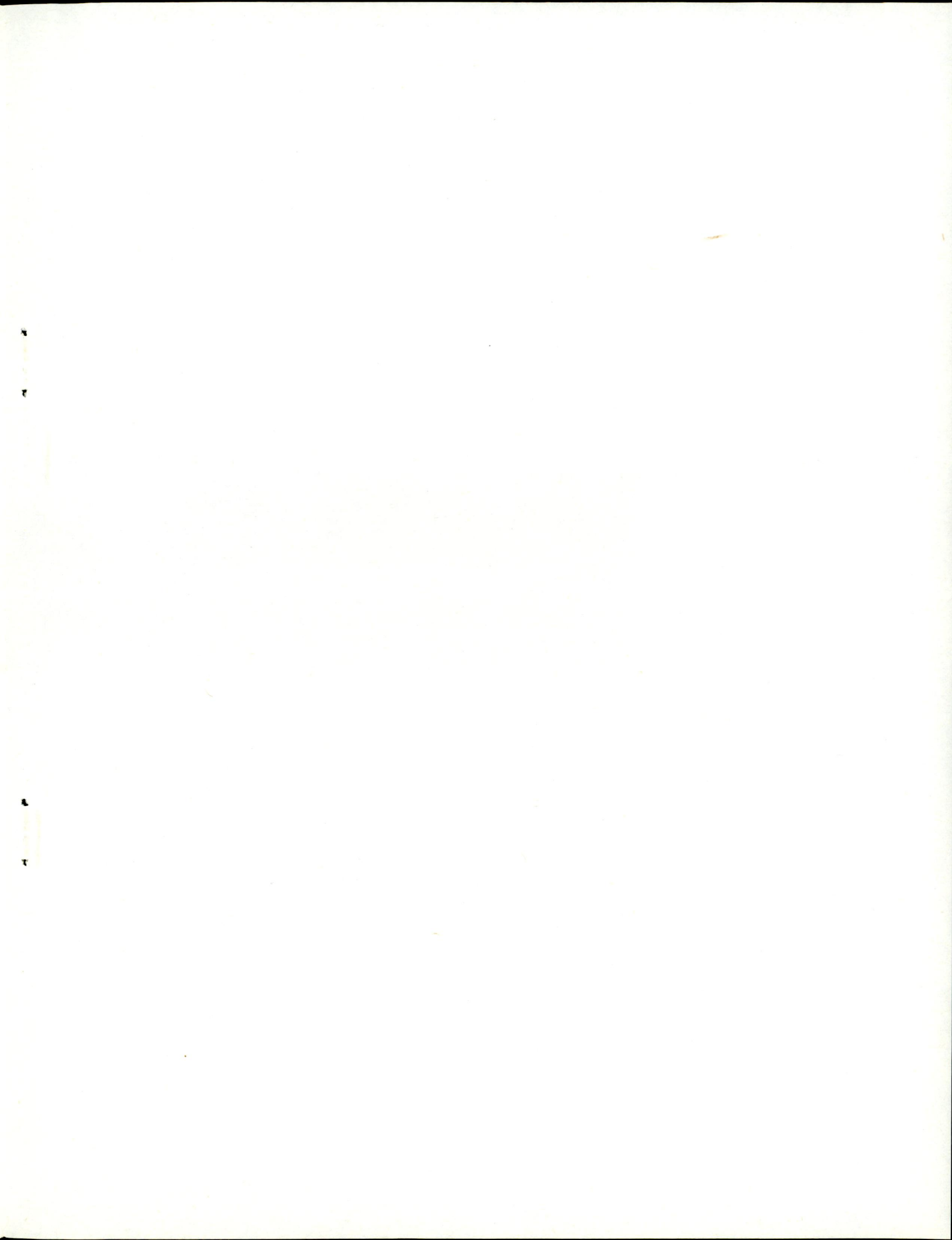

**EXPLANATORY NOTE**

THE objects of this Bill are—

- (a) to increase the superannuation allowances of certain retired members of the police force and certain widows of retired members of the police force;
- (b) to increase the superannuation allowances of certain retired employees of the Police Association of New South Wales and their widows;
- (c) to make provisions consequential upon or ancillary to the foregoing.



The Bill may be cited as the Police Regulation (Superannuation) Amendment Act, 1972.

(1) Subject to the provisions of this Act, the date of commencement of the date of superannuation shall be deemed to have commenced on 1st January 1972.
