### **EXPLANATORY NOTE**

THE objects of this Bill are—

- (a) to require persons growing potatoes on land having an area greater than one-quarter of one acre to be licensed;
- (b) to increase the amount payable out of the fund into which license fees are paid so as more adequately to meet administrative costs; and
- (c) to make other provisions of a minor nature.

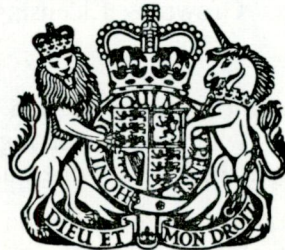
