**PRESBYTERIAN CHURCH OF AUSTRALIA (AMENDMENT)

EXPLANATORY NOTE

THE objects of this Bill are—

- (a) to overcome the effect of an inadvertent failure by church authorities to comply with certain formal requirements of the Principal Act;
