### UNIVERSITY AND UNIVERSITY COLLEGES (AMENDMENT) BILL, 1972

#### **EXPLANATORY NOTE**

THE objects of this Bill are to amend the University and University Colleges Act, 1900 (hereinafter referred to as "the Act")—

- (a) to empower the Senate of the University of Sydney (hereinafter referred to as "the Senate") to elect as Chancellor of the University of Sydney (hereinafter referred to as "the University") a person who may not be a Fellow of the Senate;
- (b) to increase the number of Fellows on the Senate-
  - (i) in the case of members elected by the academic staff—from five members to eight;
  - (ii) in the case of members elected by the students of the University—from one member to three;
  - (iii) by providing that the Chancellor of the University shall, if he is not otherwise a Fellow, become a Fellow following his acceptance of office:
- (c) to ensure that the members referred to in paragraph (b) (i) and (ii) shall be elected from among the academic staff and the students of the University, as the case may require, and that the ten Fellows elected by the graduates of the University and the three Fellows elected by the students of the University shall not be members of the academic staff of the University;
- (d) to provide that the maximum term of office of Fellows (other than ex officio Fellows) shall be four years;
- (e) to provide that elections of Fellows to the Senate, other than the Fellows elected by the Houses of Parliament, be elected in accordance with the by-laws made by the Senate;
- (f) to enable graduates under the age of twenty-one years to participate in the election of Fellows;
- (g) to repeal the provisions of the Act whereby students at the University may be required to attend divine worship;
- (h) to simplify the procedures relating to the issuing of degrees by the University;
- (i) to provide for comparability with other universities of arrangements for the determination and payment of State recurrent funds to the University by repealing the requirement for the Treasurer to make a fixed quarterly payment from a statutory endowment;

- (j) to repeal the provisions of the Act relating to the payment of lecture fees by students of the University to the academic staff of the University;
- (k) to repeal the provisions of the Act relating to residence of students and the licensing of persons with whom students may reside;
- (1) to apply to teachers and trainee teachers nominated by the New South Wales Department of Education for study at the University the entrance standards applicable to other persons seeking entrance to the University;
- (m) to repeal the provisions of the Act relating to the Board of Secondary School Studies;
- (n) to modernise the provisions of the Act relating to the payment of capital and recurrent grants to residential colleges affiliated with the University;
- (o) to make other provisions of a minor or ancillary nature.
