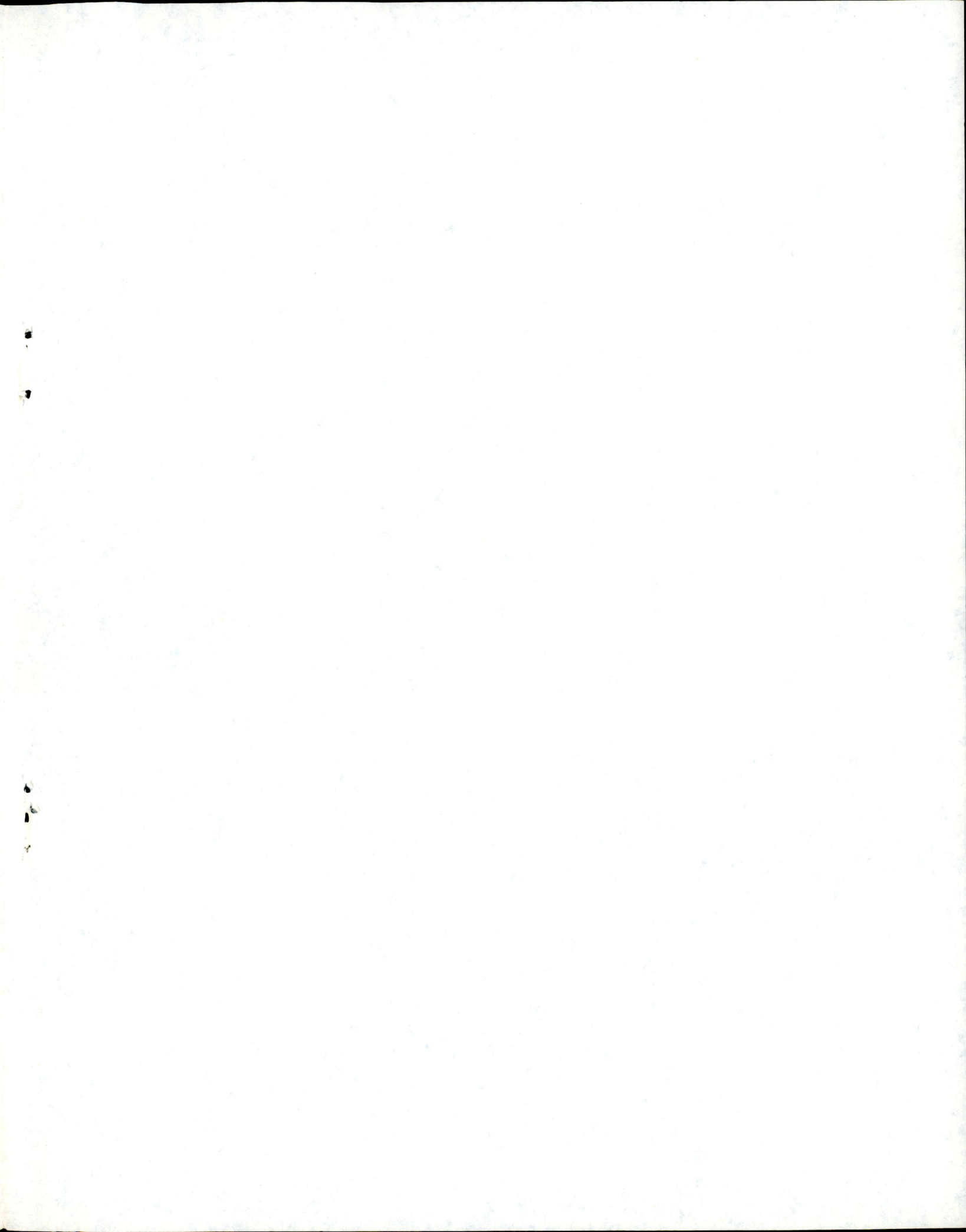

**COAL AND OIL SHALE MINE WORKERS
(SUPERANNUATION) AMENDMENT BILL, 1974**

EXPLANATORY NOTE

THE objects of this Bill are to provide that certain employees of New Redhead Estate and Coal Co. Limited and South Maitland Railways Pty. Limited (herein referred to as "the Companies") may retire or be retired after they attain the age of sixty years and before they attain the age of sixty-five years, and to validate certain payments made from the Coal and Oil Shale Mine Workers Superannuation Fund.

The Bill—

- (a) extends the definition of "Mine worker" in section 2 (1) of the Coal and Oil Shale Mine Workers (Superannuation) Act, 1941, to include certain employees of the Companies;
- (b) requires that those employees must be retired when they attain the age of sixty-five years;
- (c) provides that those employees may retire or be retired at any time after they attain the age of sixty years and before they attain the age of sixty-five years;
- (d) repeals certain Regulations made under the Coal and Oil Shale Mine Workers (Superannuation) Act, 1941, relating to matters for which provision is made in the Bill;
- (e) validates certain payments made, and authorises certain payments to be made, out of the Coal and Oil Shale Mine Workers Superannuation Fund to certain employees including certain of them who retired or were retired on or after 26th February, 1954, and before the date of assent to the proposed Act; and
- (f) makes other provisions of a minor or ancillary nature.
